SRINAGAR, Mar 17 (Agencies): An unidentified terrorist was killed in an encounter with security forces in the Zachaldara area of Jammu and Kashmir's Kupwara district on Monday, officials here said.

The security forces launched a cordon and search operation in Krumhoora village in Zachaldara following information about the presence of terrorists in the area, the officials said.

The search operation turned into an encounter after the terrorists opened fire towards the security forces' positions. One terrorist was killed in retaliatory firing and some arms and ammunition were recovered from the spot, they said.

Advocate Purnima raises concerns over insufficient healthcare infrastructure at GMC Jammu

Top News Report

JAMMU, Mar 17: Advocate Purnima Sharma, Spokesperson J&K BJP and former Deputy Mayor, highlighted pressing concerns regarding the inadequate healthcare infrastructure at Government Medical College (GMC) Jammu. She emphasized that GMC Jammu is currently overburdened, catering to the medical needs of residents from ten districts, underscoring the urgent need for infrastructural enhancements

Dr. Pardeep Mahotra, Media Incharge, J&K BJP and Arti Koul, Office Incharge, BJP Mahila Morcha were also present in the Press Conference held at party headquarter, Trikuta Nagar, Jammu.

Purnima Sharma pointed out that the existing infrastructure at GMC Jammu is insufficient to meet the growing healthcare demands of the region. She noted that the hospital presently operates with only one CT scan machine and lacks a dedicated trauma center. Consequently, patients requiring CT scans face wait



ing periods extending up to two months, leading to delayed diagno-

ses and treatments. Purnima Sharma also expressed grave concerns regarding the deplorable conditions of Shri Maharaja Gulab Singh (SMGS) Hospital in Jammu. She highlighted that the hospital's infrastructure is severely inadequate, leading to overcrowding where pregnant women, even infants, have been forced to share a single bed, even in critical areas like the emergency ward. BRIDGING SKILL GAP

ndia, one of the world's fastest-growing economies, is experiencing rapid industrialization and digital transformation. However, despite the country's demographic advantage with a young workforce, a major challenge looms large-the skill gap. The mismatch between industry requirements and the skill sets of graduates poses a significant threat to employment, economic growth, and global competitiveness. Addressing this challenge requires a multi-pronged approach involving educational reforms, industry collaboration, technological advancements, and government initiatives

The skill gap in India is largely attributed to an outdated education system that often emphasizes theoretical knowledge over practical skills. Many graduates lack the industry-relevant expertise that employers seek. According to a report by the National Skill Development Corporation (NSDC), nearly 50% of Indian graduates are not employable due to inadequate skills. The gap is most pronounced in sectors such as IT, healthcare, manufacturing, and artificial intelligence (AI), where technological advancements are evolving at an unprecedented pace.

Additionally, vocational and technical education has long been overlooked, resulting in an insufficient number of skilled workers in key trades like plumbing, electrical work, and construction. The rapid digitalization of industries has further widened the skill gap, as many workers lack proficiency in emerging technologies such as blockchain, machine learning, and cloud computing.

The traditional curriculum in many Indian educational institutions is not aligned with industry needs. The focus on rote learning and lack of practical exposure hinder skill development.

There is a significant disconnect between academia and industry. Universities often fail to equip students with the skills that industries demand, leading to a mismatch in expectations.

In addition to technical expertise, employers seek soft skills such as communication, problemsolving, teamwork, and adaptability. Many job seekers struggle in these areas, making them less competitive in the job market.

Rural and semi-urban areas face greater challenges in accessing quality education and skill development programs compared to urban centers, exacerbating the skill gap.

Many institutions and educators resist updating curricula and teaching methodologies due to bureaucratic hurdles, lack of funding, or a reluctance to adopt new technologies.

A fundamental shift is needed in India's education system to make it more skill-oriented. Institutions must incorporate experiential learning, project-based assignments, and hands-on training in their curricula. The adoption of the National Education Policy (NEP) 2020 is a step in the right direction, as it emphasizes skill development, vocational training, and flexibility in learning.

Collaboration between educational institutions and industries is crucial to align coursework with

This category includes genetic disorders, uncommon cancers, infectious diseases, and degenerative conditions. Only 5% of the more than 7,000 recognized diseases globally have effective treatments available. In India, less than half of the approximately 450 recognized rare diseases are curable. Most patients often receive only basic care that helps manage symptoms. Some treatments for rare diseases involve extremely expensive drugs and supportive therapies, making affordability a significant concern. Pharmaceutical companies often overlook rare diseases as a viable market due to the small number of patients affected by each condition. As a result, these diseases are labeled as 'orphan diseases,' and the associated drugs are called 'orphan drugs.' In India, it typically takes an average of seven years to diagnose a rare disease. Delay or misdiagnosis can greatly increase the suffering of patients. The lack of trained health professionals to recognize early symptoms of rare diseases further complicates

the situation in India. Rare diseases are conditions that affect a small segment of the population, yet they collectively affect over 70 million people in India. The National Policy for Rare Diseases 2021 seeks to address the challenges associated with their treatment, but financial limitations remain a significant barrier. With treatment costs ranging from \Box 10 lakh to \Box 16 crore per patient every year, inadequate funding mechanisms make it difficult for patients to access the necessary care, further adding to their suffering. Most rare diseases have a genetic basis and often cause serious, chronic health problems. Many lack proper diagnostic methods or treatment protocols, and existing treatments typically only manage symptoms rather than provide a cure. In India, as in many developing countries, there is no universally accepted definition of rare diseases. The burden of rare diseases in India is very high, accounting for about one-third of the global patient population. The National Policy for Rare Diseases suggests that about 50-100 million individuals in India are affected by these conditions. There are over 450 recognized rare diseases in the country, including well-known conditions such as spinal muscular atrophy and Gaucher disease. About 80-100 million Indians suffer from rare diseases, of which more than 75% are children. The high rates of morbidity and mortality associated with these serious conditions are a major reason why many of these children do not survive to adulthood.

One-time funding of \Box_{50} lakh per patient is insufficient for lifelong management of chronic rare diseases, resulting in treatment discontinuation. Although 143.19 crore has been allocated to 12 Centres of Excellence, delays in fund disbursement hinder access to essential treatments. Some Centers of Excellence have delayed using funds effectively, delaying enzyme replacement therapy for patients with Gaucher disease, despite its established benefits. Ultra-rare conditions such as acid sphingomyelinase deficiency are not covered in 2021, leaving eligible patients without financial support. In India, patients with acid sphingomyelinase deficiency are without government support, even though clinically approved treatments are available. There is no oversight to monitor fund use and provide timely treatment. Implementation of initiatives supported by Parliament is delayed, leaving patients with lysosomal storage disorders suffering without the necessary support. Long approval processes and poor inter-agency coordination lead to hindrances in treatment. Patients

Patients suffering under the burden of rare diseases waiting for funds from crowdfunding portals often face delays due to unclear eligibility criteria and procedural hurdles. The National Rare Diseases Policy 2021 relies on onetime grants rather than a sustainable funding model, making ongoing treatments unviable. Patients with lysosomal storage disorders require lifelong enzyme replacement therapy, but policy provisions phase out funding after \Box 50 lakh.

The National Rare Diseases Policy 2021 covers less than half of the more than 450 rare diseases, leaving many patients without any support. Conditions such as Pompe and Fabry disease, which have effective treatments available, are not fully covered by the policy. The absence of performance audits leads to ineffective implementation and underutilization of funds at centers of excellence. These centers have been slow to provide transparent fund disbursement, resulting in severe delays for patients with lysosomal storage disorders. Both doctors and patients often lack information about available treatments and financing options, which hinders outreach efforts. Many families who qualify for National Rare Diseases Policy 2021 benefits are not aware of these, resulting in low enrollment rates at centers. The lack of a centralized database leads to miscalculations of patient outcomes and slow policy responses. A national registry can effectively monitor real-time treatment needs, facilitating better fund disbursement and timely policy adjustments. It is essential to create a permanent government fund of over □50 lakh per patient to cover lifetime treatment expenses. Countries such as Germany and the UK have set up special funds for rare diseases, ensuring continuous patient care. We should use corporate social responsibility funding, partnerships with pharmaceutical companies, and crowdfunding efforts to augment government resources. For example, Novartis' corporate social responsibility initiative in India has provided support to spinal muscular atrophy patients requiring expensive gene therapy. It is important to expand Ayushman Bharat and state insurance programs to include lifetime treatment for rare diseases. Additionally, a digital platform should be developed to monitor fund utilization, track patient treatment progress, and ensure accountability of the CoE. Implementing a blockchainbased tracking system can guarantee transparent fund distribution without bureaucratic hurdles.

Accelerate the \Box 974 crore initiative to ensure prompt diagnosis, affordable treatment, and better infrastructure. Fast-tracking this program can greatly benefit thousands of untreated patients and help reduce child mortality. A holistic rare disease policy must move beyond mere intentions and focus on effective execution. Sustainable financing combining government support, corporate social responsibility efforts, and public-private partnerships is essential. Simplifying administrative processes, enhancing early diagnosis, and broadening insurance coverage will make treatment more accessible. A patient-centric approach supported by strong institutional frameworks is crucial to address the challenges faced by rare disease patients in India. Healthcare professionals need training to enhance their diagnostic accuracy. Pregnant mothers with a family history of rare diseases should undergo mandatory prenatal screening and postnatal care. The government should establish a clear definition of rare diseases, increase budget allocations, allocate funds for drug development and therapies, and expand the number of centers of excellence. These steps will strengthen the National Policy on Rare Diseases 2021. Both the public and private sectors should get involved in funding social support.

Simple agricultural equipment such as seed sowers, hand-operated tractors, and solar dryers is available to help reduce the burden on women. Government initiatives provide subsidies for mechanized equipment, which is beneficial for women. NGOs and government programs such as the Mahila Kisan Sashaktikaran Pariyojana provide the necessary skill training. Digital literacy initiatives empower women farmers to adopt new technological solutions. Women are increasingly getting involved in organic farming, permaculture, and climate-smart agricultural practices. Small-scale interventions such as vermicomposting pits, rooftop gardens, and agroforestry contribute to sustainable incomes. The Lakhpati Kisan initiative by Tata Trusts has trained tribal women in Jharkhand in agricultural technology and e-commerce. The Digital Green initiative uses videos to educate rural women about better farming practices. Farmer production organizations (FPOs) such as Vaagdhara help women collectively negotiate better prices. In today's world, digital technology and small interventions are playing a vital role in empowering women in agriculture. Traditionally, women have been tasked with labor-intensive and time-consuming

tasks such as weeding, threshing, and de-

hulking. However, mechanization helps

lighten their workload, allowing them

to engage in more valuable agricultural

activities. Digital tools, including mobile

apps, helplines, and advisory services, pro-

vide women with up-to-date market and weather information, which aids in better crop planning and resource management. Many women face challenges in accessing credit and financial resources, which limits their ability to invest in modern agricultural techniques. Fortunately, digital payment systems and e-commerce platforms enable women such as fish vendors and farmers to transact independently, reducing their dependence on intermediaries. By equipping women with the skills to operate agricultural machinery, these small interventions challenge ingrained gender biases and empower women to take leadership roles in farming. Access to information and technology enhances women's ability to overcome traditional barriers and assert their independence. Many women in rural areas struggle with digital literacy, which hinders their ability to effectively use mobile applications and online services. The situation is further worsened by limited access to smartphones and unreliable internet connections. Social norms continue to restrict women's participation in decision-making processes. Investment at the household level often focuses on technologies that primarily benefit men, neglecting women's unique needs. Additionally, government policies and agricultural extension services often ignore gender-specific issues. Only 13% of rural women own land, so their access to credit and agricultural programs is very limited. Increased mechanization in agriculture and fisheries has led to women losing jobs, pushing them into more unstable and informal employment. The growing dominance of large buyers and export traders in fish markets has marginalized small-scale women vendors, restricting their access to fish supplies and fair prices. Although mobile applications, online marketplaces, and digital payment systems offer new opportunities, many rural women still face barriers due to lack of smartphones, internet access, and digital skills. The report revealed that only 31% of rural women in India own smartphones, while the figure for men is 51%. To bridge this gap, government initiatives can provide subsidies for smartphones for women farmers.

Additionally, it is important to incorporate digital literacy training in self-help groups. What do you think has a greater impact in limiting women's access to technology: financial barriers or social norms? Small-scale solutions like solar pumps, digital payment systems, and microloans can bring immediate, significant improvements. On the other hand, broader reforms like land rights and the adoption of agritech will require policy changes and take more time. In Odisha, the "Mission Shakti" initiative has successfully educated thousands of women in financial literacy and digital transactions. However, the e-NAM platform, India's digital agriculture marketplace, still struggles with low female participation due to land ownership challenges. Which strategy do you find more effective for empowering women: targeted, small-scale interventions or broader systemic reforms? Several women-led agritech startups are making significant progress in this area. For example, Apurva B.K. Kamal Kisan, founded by, provides affordable agricultural equipment for small-scale farmers, while Farmizen connects women farmers directly to urban consumers through an organic farm-to-table model. Should the government consider providing dedicated funds for women-led agritech ventures? A collaborative approach that combines government policies, community initiatives, and private sector innovation is critical to ensure that women farmers in India have equal access to technology.

Online courses, virtual labs, and artificial intelligence-driven training programs can help bridge the skill gap efficiently. Platforms like Coursera, Udemy, and India's own SWAYAM provide accessible, affordable, and industry-relevant courses to millions of learners.

Given the rapid pace of technological advancements, lifelong learning is essential. Employees must be encouraged to continuously upgrade their skills through corporate training programs, certifications, and online courses. Organizations should foster a culture of continuous learning by investing in employee development.

Employability is not just about technical expertise; soft skills play a vital role in professional success. Schools and colleges should integrate communication skills, teamwork, leadership, and emotional intelligence training into their curricula. Mock interviews, group discussions, and presentation exercises can help students develop these essential skills.

With India's ambitious goal of becoming a \$5 trillion economy, bridging the skill gap is no longer optional-it is imperative. The future of work is evolving, with automation and AI transforming industries. To stay competitive, India must create a workforce that is agile, adaptable, and technologically proficient.

Encouraging entrepreneurship and fostering a culture of innovation will also play a significant role in closing the skill gap. By equipping young professionals with the right tools, India can harness its demographic dividend and emerge as a global leader in the digital economy.

Digital payment systems, including UPI, digital wallets, and online banking, enable women to secure loans and subsidies directly. Kisan credit cards and digital microfinance platforms, such as Paytm and NABARD's e-Shakti, provide financial support to women-led selfhelp groups. Filmmaking for Pranjal Khandhdiya was pretty accidental. A Guajarati, born and brought up in Mumbai, there was hardly an opportunity for an absolute outsider to enter the industry. PM Modi holds bilateral meeting with visiting New Zealand PM Luxon

NEW DELHI, Mar 17 (Agencies): PM Narendra Modi and Prime Minister of New Zealand Christopher Luxon held a bilateral meeting at the Hyderabad House in the national capital on Monday.

"PM Narendra Modi warmly welcomed PM Christopher Luxon of New Zealand at Hyderabad House today. Extensive discussions on - bilateral relationship lie ahead," MEA official spokesperson Randhir Jaiswal said in a post on X.

Luxon had arrived in the city on Sunday on a five-day official visit to India. Earlier this morning the New Zealand PM paid homage to Mahatma Gandhi at Rajghat.

The meeting comes amid a growing push to enhance bilateral ties, with both leaders set to discuss economic cooperation, trade expansion, and regional security. The visit has already seen the announcement of negotiations for a Free Trade Agreement (FTA) between the two nations.

During his visit, Luxon emphasised New Zealand's commitment to deepening ties with India, calling the Indian government "incredibly generous and very welcoming." He highlighted that he has brought the largest-ever delegation of business and community leaders to accompany a New Zealand Prime Minister on a foreign trip, underscoring the importance of strengthening economic and cultural ties. Speaking to reporters, Luxon stressed the immense potential in India-New Zealand relations and how trade expansion would benefit the New Zealand economy.

Luxon also acknowledged the significant role of the Indian community in New Zealand, noting that Indian-Kiwis are the third-largest ethnic group in the country, the largest source of skilled migrants, and the second-largest contributor to international student enrolments. He praised their contributions across various sectors, reinforcing the deep people-to-people



connections between the two nations. Luxon met with community and business leaders who travelled with him and was also seen with cricketers Ajaz Patel and Ross Taylor, further highlighting the strong cultural links between the two countries.

Luxon arrived in New Delhi on Sunday and met External Affairs Minister S Jaishankar, who appreciated his commitment to strengthening India-New Zealand relations.

Luxon is set to be the chief guest and keynote speaker at the Raisina Dialogue, India's premier conference on geopolitics and geo-economics, which will be inaugurated by PM Modi. Following his meeting with PM Modi, Luxon is expected to witness the exchange of MoUs at Hyderabad House before heading to Rashtrapati Bhavan to meet President Droupadi Murmu.

NEW DELHI, Mar 17 (Agencies): Congress leader Sonia Gandhi and West Bengal Chief Minister Mamata Banerjee were among the leaders who got in touch with the family of Vice President Jagdeep Dhankhar to inquire about his health after he was hospitalised for cardiac-related ailments.

Dhankhar revealed this in the Rajya Sabha on Monday as he resumed chairing the proceedings of the House.

He said he was "greatly touched" by the concerns expressed across party lines which contributed to his speedy recovery.

"The Leader of the House (and Union Minister Jagat Prakash Nadda) and the Leader of the Opposition (Mallikarjun Kharge) were the first ones to get in touch with my family.

"Sonia Gandhi got in touch with my wife as did the chief restrictions.

"I express my deep sense of gratitude," he said, adding there was hardly anyone who had not shown concern over his health.

Narrating his conversation with TMC leader Derek O'Brien last week, Dhankhar said he had called the opposition leader to wish him on his birthday, but he advised him to take rest.

"Derek O'Brien, irrepressible as usual, when I called him on his birthday during this period, he said shut up (and) take rest," Dhankhar said.

The period he referred to was the one when he was recuperating.

Monday was the first day when Dhankhar chaired the Rajya Sabha proceedings since being discharged from the hospital.

Earlier, Leader of the House and Union Minister Nadda wished for his speedy recovery and resumption of duties. He also wished Dhankhar good health and a long life.

Similar sentiments were echoed by Kharge. He said that he thought the Rajya Sabha chairman would not attend the House for another four to six days. Kharge said he was pleasantly surprised by Dhankhar's enthusiasm and dedication towards work and resuming office quickly.

Tulsi Gabbard, Rajnath Singh hold talks; focus on expanding defence ties

cies): Defence Minister Rajnath Singh and US Director of National Intelligence Tulsi Gabbard on Monday held wide-ranging talks focusing on enhancing the overall India-US strategic ties, especially in areas of defence and information sharing.

Gabbard arrived in the national capital early Sunday on a two-and-a-half-day trip in the first high-level visit to India by a top official of the Donald Trump administration.

In a social media post, Singh said he was "happy" to meet the US national intelligence chief and that they discussed ways to further deepen the India-US partnership.

"We discussed a wide range of issues which include defence and information sharing, aiming to further deepen the India-US partnership," he said.

Gabbard's talks with Singh came a day after she met National Security Advisor (NSA) Ajit Doval and attended a conclave of global intelligence



czars in the national capital that was hosted by India. In their one-on-one meeting, Doval and Gabbard mainly discussed ways to strengthen intelligence sharing and working closely in the security domain in sync with the India-US global strategic partnership, it is learnt. The US Director of National Intelligence, Canadian spy chief Daniel Rogers and UK National Security Advisor Jonathan Powell were among top global intelligence czars who attended the India-hosted security conclave that was chaired by Doval. The deliberations at the conclave were held behind closed doors.

It is learnt that the top intelligence and security officials focused on sharing of intelligence and cooperation to tackle terrorism and threats posed by emerging technologies.

The meeting also focused on security in the Indo-Pacific

ter terror funding and money laundering, and issues related to extradition and immigration, people familiar with the matter said.

The Indian side also raised concerns about anti-India elements operating from foreign soil, including pro-Khalistan elements, they said.

Intelligence chiefs of the UK and New Zealand and several other friendly countries of India were learnt to have attended the conclave.

The intelligence chiefs were understood to have also deliberated on various global challenges, including implications of the Russia-Ukraine war and the conflict in the Middle East. Gabbard is visiting India as

part of a multi-nation tour of Japan, Thailand and France. She will also address the Raisina Dialogue on Tuesday.

Last month, Gabbard met Prime Minister Narendra Modi during his visit to Washington DC. For how long will the BJP keep collecting "ransom" from the public, Kharge asked as he shared a media report, which said that crude oil prices are at a 42-month low, and accused the Modi government of "robbing" the people.

"The price of crude oil has been continuously falling, petrol and diesel prices have not been reduced... Modi government is robbing the public fearlessly!" Kharge said in a post in Hindi on X.

"Modi ji only tells his 'Mann Ki Baat' to the public through long onesided podcasts," he said and claimed that the PM is making people shed tears due to inflation. "Crude oil prices have fallen by 34 per cent since May 2014. Tax collection game of Rs 36 lakh crores in 10 years! When will the price of petrol and diesel be reduced?" he said.

Four children charred to death in Jharkhand's Chaibasa

CHAIBASA, Mar 17 (Agencies): Four children were charred to death in a fire that broke out in a haystack near their house in Jharkhand's West Singhbhum district on Monday, police said.

The incident happened in Gitilipi village in the Jagannathpur police station area in Chaibasa around 11 am, they said. "A team has been sent to the spot for a detailed investigation," Superintendent of Police Ashutosh Shekhar told agency.

The children were playing near the haystack when the fire broke out, he said.

The exact cause of the fire is being ascertained, he added.

Six sites added to India's tentative list by UNESCO's World Heritage Centre: Shekhawat

NEW DELHI, Mar 17 (Agencies): Six sites, including Mudumal Megalithic Menhirs in Telangana and palace-fortresses of the Bundelas in Madhya Pradesh and Uttar Pradesh, have been added to India's tentative list by the UNESCO's World Heritage Centre, Union Minister of Culture and Tourism Gajendra Singh Shekhawat said on Monday.

Other sites included in the list are Kanger Valley National Park in Chhattisgarh, Ashokan Edict Sites along the Mauryan Routes (multiple states), Chausath Yogini temples (multiple states) and Gupta temples in north India (multiple states), the minister said in the Lok Sabha.

Shekhawat said this while replying to a suggestion by BJP MP Sambit Patra to take the initiative to include Puri's Jagannath Rath Yatra in the UNESCO's list of Intangible Cultural Heritage.

Shekhawat said it was a good suggestion given by Patra.

The six new sites were added to the list



on March 7, the Permanent Delegation of India to UNESCO said in a statement. Addition to the World Heritage Centre's tentative list is mandatory if a property is to be nominated for inscription to the World Heritage List in future.

With these additions, India now has 62 sites on the tentative list, an inventory of properties each country intends to consider for UNESCO nomination.

According to the UNESCO website, the Chausath Yogini temples, considered seri-

ally, include sites at multiple locations in the country.

At present, a total of 43 properties from India are inscribed on the UNESCO World Heritage List, including 35 in the 'Cultural' category, seven in 'Natural' and one in 'Mixed' category.

India hosted a World Heritage Committee meeting for the first time in 2024, during which the Moidams — the mound-burial system of the Ahom Dynasty in Assam was accorded the coveted UNESCO tag.

Trump to speak to Putin as Russia demands *'ironclad' guarantees for Ukraine deal*

Russia is demanding 'ironclad' security guarantees in a peace treaty with Ukraine to end the three-year war, as talks advance on a US-proposed 30-day ceasefire.

WASHINGTON, Mar 17 (Agencies): US President Donald Trump said that he planned to speak with his Russian counterpart Vladimir Putin on Tuesday to further discussions on ending the war in Ukraine. It came hours after the Kremlin, on Monday, sought "ironclad" guarantees that NATO nations would exclude Kyiv from its membership and that Ukraine would remain neutral.

"We want to see if we can bring that war to an end. Maybe we can, maybe we can't, but I think we have a very good chance I'll be speaking to President Putin on Tuesday. A lot of work's been done over the weekend," the US President told reporters.

The US has proposed a 30-day ceasefire between Russia and Ukraine, and Ukrainian President Volodymyr Zelenskyy has agreed to it. Moscow has also agreed to the deal "in principle," but Russian President Vladimir Putin said that certain conditions must be addressed before signing any agreement to end the three-year war.

Stressing that any lasting peace treaty must meet Moscow's demands, Russian Deputy Foreign Minister Alexander Grushko said, "We will demand that ironclad security guarantees become part of this agreement".

Reaffirming Russia's strong opposition to NATO forces in Ukraine, Grushko stated, "Part



of these guarantees should be the neutral status of Ukraine, the refusal of NATO countries to accept it into the alliance".

He added, "It does not matter under what label NATO contingents were to be deployed on Ukrainian territory: be it the European Union, NATO, or in a national capacity".

Responding to the US peace proposals last week, Russian President Vladimir Putin stated that Moscow "supports the idea of ending this conflict through peaceful means" but emphasised the need to address fundamental issues for lasting peace.

"The idea itself is correct, and we certainly support it. But there are issues that we need to discuss. And I think we need to talk to our American colleagues as well," Putin said in Moscow.

On March 14, US President Donald Trump stated that Washington had a productive discussion with Putin and expressed optimism that there was a "very

good chance" the war between Russia and Ukraine could end soon.

"We had very good and productive discussions with President Vladimir Putin of Russia yesterday, and there is a very good chance that this horrible, bloody war can finally come to an end," Trump said, referring to the talks held by US envoy Steve Witkoff.

Putin had sent Trump a message about his ceasefire plan via Witkoff, expressing "cautious optimism" that a deal could be reached to end the conflict.

Ukraine's President Volodymyr Zelenskyy, while expressing hope for a swift end to the war, accused Putin of imposing conditions to delay the process. "Putin is afraid to tell President

Trump directly that he wants to continue this war and keep killing Ukrainians. That's why, in Moscow, they are surrounding the ceasefire idea with such preconditions that it either fails or gets dragged out for as long as possible," he said earlier. Zelenskyy has consistently said that the sovereignty of his country is not negotiable and that Russia must surrender the territory it has seized. Russia seized the Crimea peninsula in 2014 and now controls most of the four eastern Ukrainian regions since it invaded the country in 2022.

Trump said, "We will be talking about land. We will be talking about power plants".

Earlier this month, US and Russian delegations held a lengthy meeting in Jeddah, Saudi Arabia, where both countries agreed to mend their ties, with the first step being an end to the Ukraine war. Ukrainian President Volodymyr Zelenskyy strongly rejected the outcome of the Jeddah talks, stating that any decision made without Kyiv's involvement would be unacceptable.

In the following days, tensions rose between the two leaders, leading to a war of words, with even Donald Trump calling Zelenskyy a dictator. The tensions culminated in an explosive Oval Office clash, after which Zelenskyy was asked to leave the White House.

However, Zelenskyy later softened his stance towards the US while continuing to target Russian President Vladimir Putin. The US and Ukraine held talks in Jeddah last week, and subsequently, Zelenskyy announced his agreement to the ceasefire.

Prime Minister Shehbaz Sharif has asked the National Assembly speaker to convene the security meeting at Parliament House on Tuesday at 1:30 pm. Dawn reported on Monday.

The military leadership will provide a comprehensive briefing to the parliamentary committee on the prevailing security situation, according to a statement issued by the Prime Minister's Office (PMO).

The development comes in the wake of a series of deadly terror attacks in the two provinces, which share a

border with neighbouring Afghanistan.

Citing a source in the National Assembly, Dawn reported that since no parliamentary committee on security was formed, therefore, members of the Standing Committees on Defence and Foreign Affairs from the National Assembly, federal cabinet members, chief ministers of the four provinces and leaders of all parliamentary parties or their representatives will attend the closed-

door session. Prime Minister Sharif and Army Chief Gen Asim Munir will join the briefing. Meanwhile, the gov-

World Uyghur Congress hails **US sanctions on Thai officials** over Uyghur deportations

MUNICH. Mar 17 (Agencies): The World Uyghur Congress (WUC) has expressed its appreciation for the recent sanctions imposed by the US State Department on Thai officials involved in the deportation of Uyghur refugees to China. In a statement shared on the social media platform X, WUC stated, "The World Uyghur Congress welcomes and thanks the US Department of State for imposing sanctions on Thai officials involved in the deportation of Uyghurs to China. This decisive action sends a strong message that complicity in persecution of Uyghurs will not go unpunished. We urge other governments to follow this example and take concrete measures to protect Uyghur refugees and hold those responsible for their deportation accountable." The US State Department announced that it would impose sanctions on an undisclosed number of current and former Thai officials involved in deporting at least 40 Uyghur men to China, despite concerns detainees to China, calling it "unimaginably cruel." Sarah Brooks, Amnesty's China Director, emphasised that returning these Uyghurs to China exposes them to serious human rights violations, including torture, arbitrary detention, and enforced disappearance, as seen in Xinjiang. Brooks highlighted that the men had already suffered over a decade of arbitrary detention in Thailand after fleeing repression in China. The Uyghurs, a Muslim ethnic group in China's Xinjiang region, face severe persecution, including mass detention in "re-education" camps, forced labour, surveillance, cultural suppression, and torture. According to several media reports, the Chinese government's crackdown aims to eliminate Uyghur identity, religion, and autonomy, leading to widespread human rights violations and international condemnation.

The deportation of Uyghur refugees from Thailand to China has been a long-standing point of contention for human rights organisations. Human rights organisations have urged countries to adopt policies that protect the rights and safety of Uyghur refugees, ensuring they are not forcibly returned to a country where they face grave human rights abuses. Earlier, Amnesty International had also condemned Thailand's decision to deport Uyghur to attack Canada's sovereignty and economy.

This is Carney's first official foreign trip since he was sworn in on March 14. He will next land in London where he will sit down with U.K. Prime Minister Keir Starmer and King Charles III, the head of state in Canada.

Carney has deliberately chosen the two European capital cities that shaped Canada's early existence. During his swearing-in ceremony, he noted the country was built on the bedrock of three peoples, French, English and Indigenous, and said Canada is fundamentally different from America and will "never, ever, in any way shape or form. be part of the United States."

Since Trump came to office, he has imposed whopping tariffs on Canadian steel and aluminum and repeatedly commented on turning Canada into the 51st state, infuriating Canadians and sparking a call to boycott U.S. products across the country. On Monday, a senior Canadian government official briefed reporters on the plane before picking up Carney in Montreal, saying the purpose of the trip is to double down on partnerships with London and Paris. The official, who spoke on condition of anonymity as he is not allowed to speak publicly, said Canada is a "good friend of the United States but

we all know what is going on."

Carney will visit the Notre-Dame Cathedral before meeting with Macron at the Palais de l'Élysée. However, Macron isn't expected to hold a joint news conference with Carney, a sign the French president might not want to upset Trump by siding with Canada.

Before returning to Ottawa on Tuesday, Carney will travel to the edge of Canada's Arctic to "reaffirm Canada's Arctic security and sovereignty." There, he is expected to call for a federal election within days. before the Canadian parliament resumes. "The choice of this itin-

Fighting erupts along Lebanon-Syria border after 3 Syrian soldiers killed

BEIRUT, Mar 17 (Agencies): Fighting erupted along the border between Lebanon and Syria overnight into Monday, Syrian state media reported, after three Syrian soldiers were killed in earlier clashes. The violence came a month after dayslong fighting between the Syrian military and armed Lebanese Shia groups closely allied with the ousted Bashar Assad government in Syria's Al-Qasr area. Lebanon has been seeking international support to boost funding for its military as it gradually deploys troops along its porous northern and eastern borders with Syria and along its southern border with Israel. The Lebanese and Syrian armies said they are communicating with each other to ease tensions. Lebanese troops have been deployed in large numbers in the area. Families in the border areas fled toward Hermel in Syria amid the overnight clashes and shelling. Syria's interim government accused militants from the Lebanese Hezbollah group of crossing northeastern Lebanon into Syria on Saturday, kidnapping three soldiers and killing them on Lebanese soil. Hezbollah in a statement denied any involvement. The Syrian Observatory for Human Rights, a Britain-based

war monitor, said the Shia groups were involved. The circumstances of the incident remain unclear.

Svrian state media, citing an unnamed Defense Ministry official, said the Syrian army shelled "Hezbollah gatherings that killed the Syrian soldiers" along the border.

Though the clashes largely calmed before sunrise, Lebanese media reported low-level fighting at dawn after an attack on a Syrian military vehicle. The number of casualties remains unclear. The Lebanese military said it delivered the bodies of the three killed soldiers to their Syrian counterparts.

North Korea vows to 'strengthen' nuclear capabilities, rejecting G7 call for denuclearization

SEOUL. Mar 17 (Agencies): North Korea on Monday vowed to "steadily update and strengthen" its nuclear capabilities, a firm rejection of the G7's call for Pyongyang to "abandon" its nuclear ambitions.

The country's Foreign Ministry said that its "nuclear armed forces will exist forever as a powerful means of justice which defends the

sovereignty of the state, territorial integrity and fundamental interests," according to the Korean Central News Agency, a state-run media outlet. North Korea's nuclear development program "prevents a war in the Korean peninsula and Northeast Asia and guarantees a strategic stability of the world," a ministry spokesperson said on Monday.

The Minister also informed the House that there had been a provision for engagement of land donors as casual workers under SRO 520, but that has ceased to exist now and as such, there is no such policy by virtue of which employment can be provided to the land donors. The Unlawful Activities (Prevention) Act (UAPA), 1967, is India's primary anti-terrorism law which allows the government to declare organizations as terrorist groups or unlawful associations, enabling authorities to take action against them. The Act has been amended multiple times to strengthen its provisions, especially after the 2008 Mumbai attacks.

The designation of an organization as a terrorist group has serious consequences, including banning its operations in India, freezing its financial assets, preventing its members from raising funds or recruiting, and legal action against those associated with the group.

The Indian government periodically updates the list to counter evolving threats from militant, insurgent, and extremist groups operating within and outside India.



United Forum of Bank Unions calls for 2-day nationwide bank strike from Mar 23

JAMMU, Mar 17: The United Forum of Bank Unions (UFBU), a joint coordination body of nine bank unions representing over 8 lakh employees and officers across Public Sector Banks, Private Sector Banks, Foreign Banks, Co-operative Banks, and Regional Rural Banks, has announced a 48-hour nationwide bank strike. The strike will take place from midnight of March 23 to midnight of March 25, 2025.

The decision to go on strike comes as a protest against various unresolved demands that directly impact bank employees and officers. UFBU has urged the government and bank management to address these pressing concerns to avoid disruptions in banking services.

One of the primary demands of UFBU is adequate recruitment in all cadres and the regularization of temporary employees. The forum has pointed out that the shortage of staff has put excessive pressure on existing employees and affected customer service.

Another major demand is the implementation of a 5-day work week in the banking industry, aligning with the schedule followed by RBI, insurance companies, and government offices. UFBU has been pushing for this demand, citing the need for better worklife balance and consistency across financial institutions. UFBU is also call-

ing for the immediate

withdrawal of recent DFS/Govt. directives on performance review and PLI. According to the unions, these directives pose a threat to job security and create unnecessary divisions among employees.

Ensuring the safety of bank officers and staff against assaults and abuse by unruly banking customers is another key concern raised by UFBU. The forum has emphasized the need for stricter security measures to protect employees in their workplaces. Additionally, UFBU is demanding the filling of vacant posts of Workmen/Officer Directors in Public Sector Banks, as these positions have remained unfilled for a long time. They are also pushing for the resolution of residual issues pending with the Indian Banks' Association (IBA).

Another important financial demand includes the amendment of the Gratuity Act to increase the ceiling to 25 lakhs, bringing it in line with the scheme for government employees, along with a tax exemption. Similarly,

UFBU has demanded the exemption of staff welfare benefits from income tax, arguing that the management should bear the tax liability instead of employees.

UFBU is also advocating for maintaining a minimum of 51% government equity in IDBI Bank to ensure its stability and control. The forum is further urging the government to stop the micromanagement of Public Sector Banks by the DFS on policy matters affecting service conditions of employees.

In addition, UFBU has strongly opposed the outsourcing of permanent jobs in banks and has demanded an end to unfair labor practices within the banking industry.

UFBU has highlighted the severe staff shortage in public sector banks, which has significantly impacted customer service and increased the workload on employees. In contrast, Private

Sector Banks have significantly increased their workforce from 2,29,124 in 2013 to 8,46,530 in 2024 (+6,17,406).

UFBU has demanded immediate recruitment to address this growing disparity and ensure better banking services. Despite recommendations from Indian Banks to the government more than a year ago, the demand for a 5-day work week for banks has not been implemented. UFBU has pointed out that institutions like RBI, insurance companies, and many private sector organizations already follow a 5-day work schedule. The forum has reiterated its demand for immediate implementation without further delay.

With the government and bank management failing to address these critical issues, UFBU has been compelled to escalate its agitation. The two-day nationwide strike aims to bring attention to the unresolved problems affecting bank employees and officers.

UFBU has appealed to the public for their understanding and support while urging authorities to resolve these matters amicably to prevent further disruptions in banking services.

"Every moment seemed like going back in time...": Sachin Tendulkar celebrates IML 2025 title win

India Masters etched their name in history by clinching the inaugural International Masters League (IML) 2025 title, after defeating West Indies Masters by six wickets in a grand finale.

RAIPUR, Mar 17 (Agencies): Indian cricket legend Sachin Tendulkar expressed happiness at winning the International Masters League (IML) 2025 tournament with his team India Masters, saying that every moment in the competition, be it the practice sessions or match days, felt like "going back in time".

India Masters etched their name in history by clinching the inaugural International Masters League (IML) 2025 title, after defeating West Indies Masters by six wickets in a grand finale on Sunday.

Taking to his official X handle, Tendulkar wrote, "C.H.A.M.R.I.O.N.S. From practice sessions to match days, every moment at the @ imlt20official seemed like going back in time. It felt incredible to be back on the pitch alongside some of the game's greatest players. I'm grateful to everyone who made this experience so memorable, including the spectators, organizers, and my India Masters teammates." Sachin enthralled his fans with some entertaining cricket during the tournament, displaying the fitness, shot-making and agility of the days of old and triggering nostalgic memories among all cricket lovers, scoring 181 runs in six matches at an average of 30.16 and a strike rate of 153.38 with a half-century. His best score was 64.

For India, Ambati Rayadu (188 runs in five innings with two fifties at a strike rate of 142.42 and an average of 47.00), Yuvraj Singh (179 runs in five innings at an average of 179.00 and a strike rate of 184.53 with a fifty and three wickets), Stuart Binny (122 runs in four innings at an average of 40.66 with a strike rate of 187.69 and a half-century) and Irfan Pathan (113 runs in five matches at an average of 56.50 with a strike rate of 185.24 and a half-century, six wickets), Pawan Negi (nine wickets in six matches at an average of 15.66) and Vinay Kumar (eight wickets in five matches at an average of



23.62) delivered standout performances in the competition.

A tournament built on nostalgia, skill and the undying spirit of the game had delivered dream matchups, and the summit clash between the two cricketing powerhouses -- India Masters and West Indies Masters- couldn't have been more befitting of a setting for the climax. The contest had all the makings of a classic -- a packed stadium, cricketing greats rolling back the years as fans braced themselves for an epic battle after the India Masters contained the opposition for a sub-par 148/7. and then rode a fluent 67-run opening stand from Master Blaster Tendulkar (25) in the company of Ambati Rayudu (74), setting the tone for the chase.

The India Masters made a statement with their batting might as Tendulkar and Rayudu treated the packed stadium to some vintage strokeplay. While Tendulkar played with finesse, threading the field with his signature cover drives and flicks, Rayudu took the attacking route, dismantling the West India Masters bowling with calculated aggression. The 51-year-old star entertained the crowd with a couple of boundaries and a six during his fluent 18-ball knock before a sharp delivery from Tino Best ended his stay, briefly quieting the roaring stands.

Rayudu, however, ensured that the fireworks continued as India Masters cruised along towards the target. In the process, the right-handed opener got to a 34-ball fifty with a boundary off Best, even as his second-wicket stand with Gurkeerat Singh Mann (14) added another 28 runs to the Indian total. Mann perished while attempting for a glory shot to off-spinner Ashley Nurse, paving the way for Yuvraj Singh's (13 not out) arrival into the middle amid loud cheers.

Just when the India Masters were romping home towards victory, the West Indies Masters spinners delayed the inevitable with the wickets of Rayudu, who fell to left-arm spinner Sulieman Benn after belting nine fours and three mammoth sixes in his 50-ball knock, and new man Yusuf Pathan after being trapped in front by Nurse. However, with the equation down to 17 off the final 28 deliveries, Stuart Binny (16 not out) applied the finishing touches in style by smoking two gigantic sixes.

Earlier, the India Masters bowlers dictated terms after the Caribbean side opted to bat, restricting them to a modest 148/7, built mainly around Lendl Simmons' half-century.

Brian Lara (6) made a bold call by stepping up to open the innings himself. At 55, Lara's mere presence was enough to send a surge of emotion through the crowd and alongside the explosive Dwayne Smith (45), he set the stage for a dream start. The Caribbean duo tore into the new ball, racing to 34 in just under four overs, making Indian Masters captain Sachin Tendulkar and his bowlers rethink their plans.

But as they say, cricket is a great leveller, and it was Vinay Kumar who delivered one such twist by getting rid of Lara to bring the West Indies Masters' charge to a screeching halt. As the iconic left-hander walked back, the capacity crowd, which had been silenced by his side's initial onslaught, rose in unison, acknowledging not just the wicket but a cricketing great who had defined an era.

William Perkins (6) stepped in to replace Lara but soon fell victim to Shahbaz Nadeem's guile. Meanwhile, Smith continued to impose himself, smashing six boundaries and two sixes before Nadeem struck again, ending his 35-ball knock. From there, India Masters tightened their grip on the game with the spin duo of Nadeem and Pawan Negi strangling the middle order, to leave the Caribbean side gasping for momentum. Ravi Rampaul's (2) elevation in the order to combat left-arm spin didn't pay off, with Stuart Binny removing him cheaply.

Negi then dealt another body blow, castling Chadwick Walton (6) right after being dispatched for a towering six. Amidst the chaos, Lendl Simmons stood tall with a counterattacking 34-ball fifty as he held his fort to anchor the West Indies Masters innings with a vital 61-run sixth wicket partnership with wicketkeeper Denesh Ramdin (12 not out), who was happy playing second fiddle. Simmons, however, perished after facing 41 deliveries for his 57, laced with five boundaries and a six, while attempting to shift gears in the final over of the innings as India Masters eventually restricted them to a below-par total.

For the home side, Vinay Kumar emerged the pick of the bowlers, returning 3/26, while Shahbaz Nadeem came up with two wickets. Pawan Negi and Stuart Binny also chipped in with a wicket apiece.

NEW DELHI, Mar 17 (Agencies): From incessant boos to frenzied adulation—star India allrounder Hardik Pandya has seen it all in the last few months, during which his life underwent a "360 degree turnaround" and keeping himself afloat in the turmoil was his determination to "never leave the battlefield".

As he gears up for his second IPL season as Mumbai Indians captain, Pandya can expect a markedly warmer reception at the Wankhede stadium after playing crucial roles in India's T20 World Cup and the ICC Champions Trophy triumphs.

The backlash he faced in IPL 2024 was triggered by the team's decision to hand him the leadership role, replacing Mumbai's very own Rohit Sharma, who led the franchise to five trophies.

"For me, it has always been about never leaving the battlefield. There have been phases in my career where my focus wasn't necessarily on winning but on surviving and holding my ground," Pandya told 'JioHotstar' ahead of the IPL starting March 22.

"I realised that no matter what was happening around me, cricket would always be my greatest ally...I kept pushing through, and when all the hard work finally paid off, it was beyond anything I could have scripted." team for 2025. This time, we have assembled an experienced squad players who have played a lot of cricket at the highest level. That in itself is exciting."

Pandya said the side has been focussed on building a strong bowling attack, considering that Wankhede is a "challenging venue".

"Playing in the IPL in Mumbai, particularly at Wankhede, can be intimidating due to the high-scoring nature of the pitch. We wanted bowlers with experience, pace, and the ability to generate swing and bounce."

"I believe we have put together a well-balanced team, one that meets all our requirements from top to bottom. Now it's about turning up and delivering on the field." cial." "In this game, there will be highs and lows. The key is to remain balanced, not just for one season but throughout their careers," he said. Pandya said all one needs is a little patience to navigate the tough

times. "In terms of skill set, they are far ahead of where we were at 21 or 22. Their talent and fearless approach are already there—it's just about reinforcing their belief in themselves." MI will open their IPL campaign against Chennai Super Kings in Chennai on March 23.


wished them good luck in their future endeavor.

Dimple leads protest against land allotment to outsiders in J&K, demands statehood restoration

JAMMU, Mar 17; Sunil Dimple, President of Mission Statehood, led a strong protest and demonstration against the allotment of land to 200 outside investors for business in Jammu & Kashmir. He alleged that J&K is on "grand sale" and that the region's demography is under threat.

Addressing the protest, Dimple claimed that since the abrogation of Article 370, lakhs of canal lands have been allotted to investors from states like Uttar Pradesh, Harvana, Delhi, Maharashtra, Punjab, Gujarat, and others. He further accused the Jammu **Development Authority** (JDA) and the Housing Department of selling flats to outsiders.

Dimple urged Chief Minister Omar Abdullah to disclose in the Assembly the conditions and terms under which land has been allotted to outsiders for residential and business purposes. He stressed that this move is a serious threat to the demography of Jammu & Kashmir, par

ticularly the Dogra state.

He demanded that 100% of jobs in these industries be given to local youth and that land be allocated on a 100-year lease basis instead of outright sale. He further accused the Bharatiya Janata Party (BJP) of refusing to restore Jammu & Kashmir's statehood and compared its actions to those of the East India

Company, alleging that the region is being exploited. Dimple also claimed

that after the downgrade of J&K to a Union Territory, various resources, including power projects, have been sold off. He raised concerns over the influx of liquor and mining mafias and criticized the discontinuation of the traditional Darbar Move.

Raising the issue of liquor sales, Dimple alleged that alcohol is being openly sold in hotels in Katra, with viral videos circulating on social media as proof. He urged Chief Minister Omar Abdullah to introduce a bill in the Assembly to ban the sale of liquor in Jammu

Additionally, he demanded that Lieutenant Governor Manoi Sinha and Chief Minister

& Kashmir.

Omar Abdullah reinstate the Darbar Move from April this year. Dimple also strongly criticized the BJP, the Prime Minister, and the Home Minister for their lack of commitment to restoring Jammu & Kashmir's

statehood. Expressing concerns over law and order, he alleged that the situation in J&K has deteriorated, with incidents of kidnappings and later recovery of dead bodies becoming frequent. He claimed that when people protest for justice, they are met with brutal police action, including violence against women. He pointed out that several videos of these excesses have gone viral in the media.

Several senior leaders, including Mohinder Kumar, Sudesh Kumar, Bishan Das, Sudershan Sharma, Mohan Lal, Sanjay Sharma, and Bram Data, participated in the protest, expressing solidarity with the demands put forth by Mission Statehood.
