Body of third missing gujjar youth recovered in South Kashmir

SRINAGAR, Apr 11 (Agencies): The body of the third missing tribal Gujjar youth was recovered on Friday from a stream in Jammu and Kashmir's Kulgam district, officials said.

The deceased, identified as Mukhtar Awan, had been missing since February 13, along with his cousins Riyaz and Showkat Bajad, all residents of Chandian Pajan village in Kulgam district. The trio had set out that evening to attend a relative's wedding in Mahgund village, around 10 kilometres away, but never reached their destination.

A month after their disappearance, the bodies of two brothers Riyaz and Showkat were found in a stream between the

two villages. While officials claim the two had drowned or died by suicide, the families refused to believe this

version. On Friday, the body of third missing youth Mukhtar Awan was recovered from a stream, which has further added to the tension already

prevailing the area. The body of the third missing youth was spotted by the locals Vaishow Nallah and they informed the police. The body was later shifted to District Hospital Kulgam for medico-legal formalities," official said.

BJP leader and former law maker Chowdhary Zulfkar Ali reiterated his demand to the State Government to institute a magisterial inquiry into the inexplicable deaths of three individuals.

"This silence is unacceptable, and it is essential that the government takes action as per the law of the land. The affected families are entitled to adequate compensation relief," he said.

Terrorist killed in encounter in Kishtwar; Combing Ops underway in Udhampur

JAMMU, Apr 11 (Agencies): One terrorist was killed Friday in an encounter with security forces in Jammu and Kashmir's Kishtwar district, while a separate operation to track down a group of three militants is underway in Udhampur district, Army officials said.

The security agencies have expanded the scope of surveillance to the Bhaderwah area of Doda district to keep a track on terrorists potentially moving between different locations in the hilly districts of the Jammu region.

The officials said the encounter in Kishtwar broke out during an intelligence-based searchand-destroy operation launched jointly by the Army and the Jammu and Kashmir Police in the Chatru forest area of the district.

During the operation, the forces established contact with the terrorists. "The terrorists were effectively engaged, and a firefight ensued. One terrorist has been neutralized so far," the Army's White Knight



Corps. or 16 Corps. said in a post on X.

"Despite hostile terrain and adverse weather, our brave soldiers continue relentless operations," it added.

Special forces braved high-snow areas and treacherous terrains to track down one terrorist, while a few others are still on the move under significant pressure from security forces, the officials quoted above said.

A brief exchange of fire with terrorists occurred in the Naidgam area of Chatru on Wednesday resulting in launch of massive combing opera-

The slain terrorist reportedly was a part of the Saifullah module of Pakistan, but it has not been officially confirmed. This is the module that ambushed an army team in Doda on July 15, 2024, resulting in the death of an officer and a rifleman.

Security forces have intensified surveillance in the high-altitude areas of the Bhaderwah area of Doda district, considering the melting snow in the higher meadows, a major factor contributing to infiltration during summer months.

Supported by helicopters and drones, troops are maintaining a high degree of surveillance in high-altitude areas connecting Kishtwar, Udhampur, and Kathua districts, they said.

There have been five encounters in the past

19 days in the mountainous terrains of Kathua-Udhampur-Kishtwar, in which three terrorists were killed. Four police personnel were also killed, while three other police personnel and a girl sustained injuries.

Search operations resumed Friday in the Jopher-Marta forests in Udhampur district, officials said.

Equipped with sniffer dogs and aerial surveillance, multiple security agencies are combing the entire forest area to track down three terrorists hiding in the area, they added.

The areas have been placed under night cordons to prevent terrorists from escaping, the officials said.

On Wednesday, during a search operation by police and other security forces, contact was established with terrorists in the Jopher-Marta belt in the Ramnagar police station area of Udhampur, leading to an encounter. "Two to three terrorists are believed to be trapped," said Senior Superintendent of Police





Landmark Diplomatic Victory for India

The consistent and concerted efforts of Prime Minister Narendra Modi and his NDA government bore fruits the other day when a US Court gave its judgment and ordered the extradition of the mastermind of 26/11 Mumbai terror attack to India. Today 10th of April 2025 is really a great day of triumph for Modi's diplomacy as on this day Tahawwur Rana was finally extradited to India and reached new Delhi. All the options had been exhausted and finally the mastermind of 26/11 attack has been handed to India . Now the terrorist will be tried as per the law of the land and centre government has constituted a special cell of NIA for handling this case. The accused will be produced before the judicial magistrate in Delhi which will order his remand to NIA. The people of Mumbai in particular and the Indians in general demand death sentence for him. While the US Court decision is the big diplomatic win for India, it is a big slap on the face of Pakistan. So in a major win for India, a US appeals court has approved the extradition of the mastermind of the 26/11 Mumbai terrorist attack, David Coleman Headly ,and has links to Lashkar -e-Tabia and the ISI, as per a 405 -page charge sheet.26/11 Mumbai attack accused Tahawwur Rana will be extradited to India .In a big win for India, a U.S appeals court has approved the extradition of Tahawwur Hussain Rana ,a Pakistani-origin Canadian businessman accused of involvement in the 2008 Mumbai terror attack. "The India-US treaty permits Rana's extradition," the court said in its ruling on August 15,2024.In a major setback to Pakistan -backed terrorist Tahawwur Rana, who is sought by India for his involvement in the 2008 Mumbai terror attack, the US Court of Appeals for the Ninth Circuit has ruled that he is extraditable to India under the extradition treaty between the two countries. The -India -US Extradition Treaty permits Rana's extradition,"the court said in its ruling on August 15,2024. Ruling on an appeal filed by Rana

,a panel of Judges of the US Court of Appeals for the Ninth Circuit affirmed the District Court in the Central District of California's denial of his habeas corpus petition challenging a magistrate Judge's certification of his as extraditable to India for his alleged participation in terrorist attacks in Mumbai in November 2008. It is after a long gap of 20 years from the terror attack in Mumbai that the mastermind accused is being extradited to India, where he will face the punishment as per Indian laws. Today the dreaded terrorist who conspired the deadly serial terrorist in Mumbai in September 11,2008 has finally been extradited and handed over to India and he reached New Delhi. It is in fact a victory of Modi's diplomacy. The extradition of the Rana is the result of the constant efforts of the Modi government and his extradition is the big diplomatic win for India .A US court approved the extradition of Chicago businessman Tahawwur Rana to India where he is wanted for his role in the 2008 terror attack in Mumbai. Rana was convicted in 2011 of supporting an Islamic militant group blamed for the attack on India's financial capital Mumbai that killed 166 innocent and unarmed civilians. But he was cleared of the more serious charge of helping plot the attack. The businessman was arrested after an extradition request by India in 2020. Rana, who denied all the charges against him, had challenged India's extradition request which was also supported by the US government. But a court on charged Monday consented his extradition. The court said that Rana had been in India with criminal conspiracy, committing terrorist acts and murder -all of which are extraditable offences as per the treaty between US and India .It ,however ,added that Rana will remain in US custody till the Secretary of state to India takes a final decision on his extradition. More than 160 people were killed in November 2008 when a group of 10 men stormed a train station ,hotels and cafes and a Jewish centre, shooting and throwing bombs. Indian authorities accused Rana ,a Pakistani born Canadian of conspiring with his childhood friend David Coleman Headely to assist Pakistani

militant group Lashkar -e-Tabia [LeT], which was blamed for the attack. Prosecutors in the case said that in 2006 .Rana allowed Headely to open an office of his Chicago based immigration services firm in Mumbai, which Headley then used as cover to scout sites for the 2008 attack. Rana was also accused of allowing Headley to pose as a representative of his firm in order to gain access to newspaper offices by feigning interest in purchasing advertising space. Headley ,who is serving a 35 -year jail term in the US for his role in the attacks ,testified against Rana in 2011.Rana's defense team at the time said he was manipulated and mislead by Headley, an old friend from their days in a Pakistani military school .In 2011.jurors at the federal court in Chicago convicted Rana of providing support to LeT and for his role in an aborted plot against a Danish newspaper .But he was cleared of charges of direct involvement in the Mumbai attacks .In 2013,he was sentenced to 14 years in prison .In 2020 ,Rana was released from jail in the US on the compassionate grounds for testing positive for the Covid-19. He was arrested again after the extradition request by India . The US court agreed to extradite Tahawwur Rana to India for 2008 attacks, marking a pivotal development in the 2008 Mumbai attacks case .Rana, linked with LeT ,played a significant role in orchestrating the attacks. After prolonged legal proceedings, the court ruled the evidence aligns with the India-US extradition treaty. Mumbai terror accused Tahawwur Rana approaches US Supreme Court to challenge extradition to India. Rana faces charges for his role in the 26/11 Mumbai attack and is known to be associated with Pakistani - Amercian Lashkar-e-Taiba - LeT terrorist David Coleman Headley ,one of the main conspirators of the terror incident that hit India's financial hub in 2008. Having lost his legal battle in all lower courts, Mumbai terror attack accused Tahawwur Rana, a Canadian national of Pakistani origin, has now knocked on the doors of the US Supreme Court against his extradition to India .India has sought Rana's extradition for his involvement in the 2008 Mumbai terror attack

.Rana has last reached out to the US Court of Appeals for the North Circuit in San Francisco after losing the legal battle in lower courts and several federal courts .On September 23,the circuit court threw out his petition to give a stay on the decisions of the other courts that approved the move of the Department of State to extradite him to India. On November 13, Rana filed a "petition for a writ of certiorari "before the US Supreme Court. In a long battle, this was Rana's last legal chance not to extradited to India. In his "petitions for a writ of certiorari to review the judgment of the United States court of Appeals for the Ninth Circuit ."In this case ,Rana made the same argument that he was tried and acquitted in federal court in the Northern District of Illionis - Chicago on charges relating to the 2008 terrorist attack on Mumbai. India now seeks to extradite him for trial on charges based on the identical conduct at issue in Chicago case," it says. The petition says that if the 'elements' standard applies , he very likely will be sent to India to be put on trial a second time for the same conduct, with conviction and death sentence ominously on the horizon for him,"In addition, resolution of this issue will have considerable and increasing impact, as the growing globalization of criminal law enforcement and international cooperation , which in turn has led to a dramatic rise in extradition, will affect more and more individuals and nations going forward,"it said .In brief now the US Court has approved Rana's extradition to India who will face legal trial here and it is a big diplomatic win for India. The mastermind of Mumbai bombing attack called 26/11 has finally been handed over to India and it is the diplomatic win for India

The game of the private system: Attack on the common man's

→n India, basic rights like education and health have **▲** become a source of profit for private institutions. Private schools charge arbitrary fees from parents in the name of facilities—dress, books, uniforms, coaching-everything has been made expensive and compulsory. On the other hand, private hospitals charge huge amounts from patients by creating an atmosphere of fear and confusion. By declaring a normal disease as serious, pressure is created for expensive tests, medicines, and admission. There is political patronage behind these institutions, due to which no strict action is taken. The middle class is in the greatest crisis, which neither trusts government services nor gets relief from the private system. This is a warning that if the public does not raise its voice even now, education and health will remain mere privileges.

India is a country where education and health are considered basic rights. But when these rights take the form of a business, then these rights become a burden in the life of the common man. In today's era, private schools and private hospitals have created such a system in the name of facilities that directly attacks the pocket of the common man. This attack is not only economic but also mental and social.

Education or business?

Talking about private schools, these educational institutions now seem less like schools and more like five-star hotels. Lakhs of rupees are collected for admission in schools in the name of different items like donation, admission fees, annual charges, dress, books, shoes, bus fees, etc. Books have to be bought from the school's 'authorized vendor,' whose

price is double the market rate because the school's commission is included in it. School uniforms also have to be bought from them, which are not available in the general market.

All this is not because parents demand these facilities but because schools have made it 'compulsory.' The thing called studies now happens less in the classroom and more in coaching institutes—and the interesting thing is that the owners of those coaching institutes are also often associated with the same school operators. The child goes to school all day, then coaching, then homework, and then tuition—no time for oneself, no thinking, no childhood.

The aim of all these is the same—'get' 99%.' And when these marks are not achieved, the children suffer from an inferiority complex. Parents start comparing them with other children, and this whole process turns into mental harassment.

Health name, business work
Now if this is the situation in
education, the health sector is
even more horrific. The structure of private hospitals is now
more focused on 'earnings' than
treatment. As soon as you enter
the hospital, a 'slip' is issued,
then various tests, expensive
medicines, ICU, and demand
for 'advance payment'—and'
that too without telling you what
the condition of the patient is.

Doctors treat even a common cold, cough, or fever as if life is in danger. By scaring people, they are advised to take long-term medicines and get admitted. Even if the patient recovers, the family gets sick after seeing the bill. The medicine, which is available outside for Rs. 10, costs Rs. 200 to 300 in the hospital bill.

Even after death, the body is kept for a day or two, and money is collected till the last breath in the name of 'mortuary charges,' 'freezer charges,' etc. This is a cruel joke on the family, which has already lost its loved ones. Government's silence—why?

The saddest aspect of this loot is that no one has to do it secretly—everything happens openly. Newspapers, social media, and news channels—this issue is raised everywhere. Every year there is a hue and cry over the fee hike of private schools and hospital bills, but every time this hue and cry is slowly suppressed.

Why? Because most private schools, colleges, and hospitals—there is some politician behind all of these. Whether he is from the ruling party or the opposition, most of the people sitting in the system are somehow involved in this game. Rules and laws are made, but they are not implemented.

RTE (Right to Education Act), CGHS (Health Care Scheme), and National Medical Council these are all mere names used for publicity and not for providing relief to the common man.

The tragedy of the middle class
The government sometimes
makes plans for the poor; the
rich have no worries, but the
middle class suffers the most.
They are neither willing to be
sent to a government school
nor to a government hospital.
Out of helplessness, they choose
the private option and then get
caught in the same trap—a trap
in which there is no control, no
accountability.

The middle class neither takes to the streets nor protests. Every month it cuts its pocket to pay EMI, pays school fees, pays hospital bills, and thinks only this: "There is no other way."

Solution possibilities

If this problem is to be really tackled, some concrete steps will have to be taken. Transparency of private institutions—Schools and hospitals should publicly display information about their fees and services on websites and notice boards.

There should be an independent regulatory body that monitors fees and quality of service. A system where common citizens can register their complaints and they are resolved in a timely manner. It should be ensured that the interests of any political person or their family are not linked to these institutions. Unless the general public unites and raises its voice, this chain of loot will continue.

Education and health are no longer a 'service'—it' is now a 'service' whose price is determined by your pocket. This situation is shameful for any sensitive and democratic society. Unless we wake up, raise our voice, and demand accountability from the system, this private system will continue to rob us like this.

We have to understand that by joining the race of showing off, we are putting our children's childhood, our family's peace, and our future stability at stake. This is the time to ask questions, to show the mirror to the system—otherwise not only your pocket will be lost, but selfrespect will also be lost.

Chahatt said that divorces and separations are never easy, especially when one has children, and added, "My second separation was very difficult. My one daughter stays with Farhan and one stays with me, and we are on decent terms. We speak to each other for the kids because they are our responsibility. Any kind of divorce is painful. It's not easy. Plus, if you are a known



person, it becomes difficult to face others. There were a lot of times when I didn't want to go and face people because I knew they'd judge me. I haven't taken any alimony from either of my husbands. But people comment that I am a gold digger. I was like, where is the gold? People message me and DM me, saying that I am living on alimony. This is also a taboo."

She further spoke about the stigma surrounding divorce in the industry and said, "Many people didn't want to work with me. Aapka naam bad light mein hain toh a lot of people don't want to associate with you. Aapke personal affairs itne media mein hain toh logon ko aapke saath kaam nahi karna hai (If your name is in a bad light, a lot of people don't want to associate with you. If your personal affairs are all over the media, people don't want to work with you). A-list production houses will not work with you. People at the manager level told me to my face that they want to skip it out because of the things in the press and media."

Chahatt met businessman Bharat Narsinghani when she was 16. The couple dated for six years before getting married in December 2006. However, four months later, they parted ways, with the actor alleging that Narsinghani and his family had physically and emotionally abused her.



Fire engulfs three floors of residential tower in Surat, 18 rescued

SURAT, Apr 11 (Agencies): A fire broke out at a residential tower in Surat on Friday morning, after which 18 persons trapped on its terrace were rescued, an official said

At least 10 injured after vehicles collide on Rajasthan highway

The accident occurred on National Highway 48 after one vehicle lost control, leading to a chain collision involving six other vehicles. The impact caused significant injuries to several individuals.

Local residents rushed to help and assisted in taking the injured to a nearby hospital.

According to preliminary information, most of the injured are workers of a solar company based in Dudu. They were reportedly travelling from Padasoli to Dudu when the incident happened.

Couple held for killing nephew found in 'objectionable condition' with girl

BAHRAICH, Apr 11 (Agencies): The police here have arrested a man and his wife for allegedly strangling their 22-year-old visiting nephew to death after finding him in an "objectionable condition" with a girl from their family, officials said on Friday.

The body of Bhanu Pratap, alias Sudhir, was found on March 29 near a school outside Dharmanpur village in a sack with a rope tied around his neck.

Additional Superintendent of Police (Rural) Durga Prasad Tiwari told reporters on Friday that Bhanu, a resident of Aurahi village in the district, was visiting his maternal uncle, Chetram Gautam, in Dharmanpur when the alleged incident happened.

Bhanu's father has accused Chetram and his family of the alleged murder, the ASP said.

Tiwari said that police investigation, which involved analysing CCTV footage, mobile records, call details, witness statements, and circumstantial evidence, pointed to Chetram and his wife. Sundari Devi, as the perpetrators.

"The couple allegedly took this step after finding Bhanu in an 'objectionable condition' with a young girl from their family," the officer stated.

"During interrogation, the accused (couple) confessed to the crime, admitting they stuffed Bhanu's body in a sack, tied a rope around his neck to mislead investigators, and disposed it off near a government school. They carried the body on a motorcycle,' the officer added.

ASP Tiwari said a postmortem examination was conducted.

The police conducted a thorough investigation and arrested the couple on Thursday, subsequently sending them to jail.

Xi Jinping to visit three Southeast Asian countries in his first foreign tour after Trump's tariffs

BEIJING, Apr 11 (Agencies): Chinese President Xi Jinping will visit three Southeast Asian countries early next week to strengthen regional cooperation in his first tour abroad after US President Donald Trump slapped 145 per cent tariffs against China's exports intensifying the trade war with Beijing.

Xi will pay state visits to Vietnam, Malaysia and Cambodia from April 14 to 18, the Chinese Foreign Ministry announced on Friday.

All three countries are part of the Association of Southeast Asian Nations (ASEAN) grouping with which China had the largest trade amounting to USD 962.28 billion last year, with China's exports totalling USD 575 billion.

Many Chinese observers warned the competitive trade nature between China and its Asian neighbours — since they are all export-driven economies with the US being one of their key markets — could hinder Beijing's efforts to rally them, a dilemma further compounded by territorial disputes on both land and sea.

Though Xi's visits to these countries were on the cards for a while, the timing of the visits coincides with Trump's tariffs against Chinese goods while pausing levies against the rest



of the countries.

According to the latest US notification, the overall trade tariffs on China amounted to 145 per cent.

China retaliated with 84 per cent tariffs, imposed some restrictions on imports of some US films and expressed interest in holding a dialogue with Washington to resolve the issue.

China remained the only country which retaliated against Trump's tariffs.

Vietnam, Malaysia and Cambodia were too hit hard by US tariffs but sought time to work out bilateral trade tariffs.

As Trump's tariffs loomed large on China, Xi earlier this week sought to strengthen China's strategic relationships

with neighbouring countries by appropriately managing differences and enhancing supply

In his first public speech after Trump's steep global hike of tariffs, Xi called for building a community with a shared future with neighbouring countries and striving to open new ground for China's neighbourhood work, state media reported.

Xi made the remarks at the high-level central conference on work related to neighbouring countries.

The two-day conference on Tuesday and Wednesday was attended by top officials from the ruling Communist Party.

China has been steadily recasting its neighbourhood

policies as its relations with the US become increasingly strained.

China recently scaled down border tensions with India and sought to improve its relations with other neighbours like Japan and South Korea, bracing for tough times under Trump's presidency on trade and strategic fronts.

The India-China relations, which have been frozen for over four years over the eastern Ladakh military standoff, showed signs of improvement after Xi met Prime Minister Narendra Modi at Kazan in Russia last October.

Since then, the two countries have held a series of high-level meetings to normalise relations.

Recently, China held trade talks with South Korea and Japan, the first economic dialogue between the three countries in five years, to discuss regional trade facilitation as the countries braced for Trump's tariff announcement.

The trade ministers of the three countries discussed free trade agreements to promote regional and global trade.

China is also ramping up trade relations with several other countries in the neighbourhood under its Belt and Road Initiative (BRI).

China hits back with 125% tariffs on US goods, will 'ignore' any more Trump levies



BEIJING, Apr 11 (Agencies): China on Friday announced an increase in tariffs on US goods from 84 per cent to 125 per cent, shortly after President Donald Trump unveiled a steep hike in duties on Chinese imports, raising them to a staggering 145 per cent. However, it also noted that it would not retaliated any further.

"The US imposition of abnormally high tariffs on China seriously violates international and economic trade rules, basic economic laws and common sense and is completely unilateral bullying and coercion," news agency quoted the Chinese finance ministry as saying.

The ministry also said that it would "resolutely take countermeasures"

and fight to the end if the US insisted on continuing to infringe on China's interests in a

substantive way.

It also made it clear that the country would not retaliate any further even if the US continues to import additional tariffs on Chinese goods. "If the US continues to impose additional tariffs on Chinese goods exported to the US, China will ignore it," the ministry said.

The hike followed sustained pressure from the White House on the world's second-largest economy and leading US import source, which was specifically targeted for an additional tariff increase — despite Washington easing similar 'reciprocal' duties on other nations.

The White House clari-

fied that Trump's 90-day tariff 'pause' excludes China, which will instead face a sharp increase in US tariffs, rising to 125 per cent.

In his first reaction to Trump's tariff onslaught, Chinese premier Xi Jinping urged the European Union to join forces with Beijing to resist what he called "unilateral bullying".

"China and Europe should fulfil their international responsibilities... and jointly resist unilateral bullying practices," state news agency Xinhua quoted Jinping as saying.

Earlier, China imposed tariffs of up to 84 per cent on US goods starting Thursday, up from the previously declared 34 per cent. China also filed a new complaint with the World Trade Organization, stating that US tariffs threaten global trade stability.

In addition, China added 12 US companies to its export control list and placed six others on its unreliable entities list in response to actions taken by Trump.

UN denounces Myanmar junta's attacks on minorities, rebels despite post-quake ceasefire

GENEVA, Apr 11 (Agencies): The United Nations rights office decried Friday attacks by Myanmar's military despite a ceasefire declared following last month's devastating earthquake, which killed more than 3,600 people.

"At a moment when the sole focus should be on ensuring humanitarian aid gets to disaster zones, the military is instead launching attacks," spokeswoman Ravina Shamdasani said in a statement.

UN rights chief Volker Turk, she said, "calls on the military to remove any and all obstacles to the delivery of humanitarian assistance and to cease military operations."

A multi-sided conflict has engulfed Myanmar since 2021, when Min Aung Hlaing's military wrested power from the civilian government of Aung San Suu Kyi.

Following reports of sporadic clashes even after the March 28 quake that so far is known to have killed at least 3,645 people, the junta joined its opponents last week in calling a temporary halt to hostilities for relief to be delivered. But Shamdasani highlighted that since the earthquake, "military forces have reportedly carried out over 120 attacks."

"More than half of them (were) after their declared ceasefire was due to have gone into effect on 2 April," she

The UN rights office had determined that most of these involved aerial and artillery strikes, she said, "including in areas impacted by the earthquake."

"Numerous strikes have been reported in populated areas, many of them appearing to amount to indiscriminate attacks and to breach the principle of proportionality in international humanitarian law."

Shamdasani pointed out that areas at the epicentre of the quake in Sagaing, particularly those controlled by opponents of the military, "have had to rely on local community responses for search and rescue, and to meet basic needs."

"Clearly these valiant efforts need to be further supported," she said, calling for "common efforts to assist those in greatest need."

"In this spirit we call on the military to announce a full amnesty for detainees it has incarcerated since February 2021, including State Counsellor Aung San Suu Kyi and President U Win Myint"

Taliban publicly executes 4 for murder: Afghan Supreme Court

KABUL, Apr 11 (Agencies): Four men were publicly executed in Afghanistan on Friday, the Supreme Court said, the highest number of executions to be carried out in one day since the Taliban's return to power.

The executions in three separate provinces brought to 10 the number of men publicly put to death since 2021, according to an agency tally.

Public executions were common during the Taliban's first rule from 1996 to 2001, with most of them carried out publicly in sports stadiums.

Two men were shot around six or seven times by a male relative of the victims in front of spectators in Qala-i-Naw, the centre of Badghis province, witnesses told an agency journalist in the city.

"They (the convicted men) were made to sit and turn their backs to us. Relatives from the victims' families stood behind and shot them with a gun," Mohammad Iqbal Rahimyar, a 48-year-old spectator, told agency.

The men had been "sentenced to retaliatory punishment" for shooting other men, after their

cases were "examined very precisely and repeatedly", the Supreme Court said in a state-

The families of the victims turned down the opportunity to offer the men amnesty, it said.

"If the family of the victim had forgiven the men it would be better, otherwise it's God's order, and should be implemented," a 35-year-old man who gave his name as Zabihullah told agency outside the stadium.

Afghans had been invited to "attend the event" in official notices shared widely on Thursday.

A third man was executed in Zaranj in Nimroz province and the fourth was in Farah city in the western province of the same name, the Supreme Court said.

"It's good that the Islamic Emirate shows its politics and force. I am very happy with that," said another 30-year-old spectator named Javid, referring to the Taliban government's official name

Eye for an eye

The previous execution was in November 2024, when a convicted murderer was shot

three times in the chest by a member of the victim's family in front of thousands of spectators, including high-ranking Taliban officials, at a stadium in Gardez, the capital of eastern Paktia province.

Corporal punishment -- mainly flogging -- has been common under the Taliban authorities and employed for crimes including theft, adultery and alcohol consumption.

However, all execution orders are signed by the Taliban's reclusive Supreme Leader Hibatullah Akhundzada, who lives in the movement's heartland of Kandahar.

Akhundzada ordered judges in 2022 to fully implement all aspects of the Taliban government's interpretation of Islamic law -- including "eye for an eye" punishments known as "qisas", allowing for the death penalty in retribution for the crime of murder.

Law and order is central to the severe ideology of the Taliban, which emerged from the chaos of a civil war following the withdrawal of Soviet forces from Afghanistan in 1989.

One of the most infamous images from their first rule depicted the 1999 execution of a woman wearing an all-covering burqa in a Kabul stadium.

She had been accused of killing her husband.

The United Nations and rights groups such as Amnesty International have condemned the Taliban government's use of corporal punishment and the death penalty.

Amnesty included Afghanistan in countries where "death sentences were known to have been imposed after proceedings that did not meet international fair trial standards", the non-governmental organisation said in its annual report on death sentences published in April.

The report said Iran, Iraq and Saudi Arabia were responsible for 91 percent of known executions last year, with increases in death sentences in all three countries spurring a global rise.

The 1,518 executions recorded worldwide in 2024 did not include thousands of people believed to have been executed in China -- the world's leading executioner -- Amnesty said.

US Energy Secretary lauds UAE as 'strategic partner' in energy, AI

ABU DHABI, Apr 11 (Agencies): The US Secretary of Energy, Chris Wright, emphasised the strong and growing strategic partnership between the United States and the United Arab Emirates in the fields of energy, artificial intelligence (AI), and advanced technology during his visit to the UAE.

Wright, who is in the UAE as part of his first official international trip, described the bilateral relations with the UAE as witnessing "rapid growth" in investment and joint cooperation. His regional trip, which includes three countries, aims to strengthen ties with key geostrategic and energy allies.

During a visit to ADNOC HQ, Wright expressed his admiration for the UAE's early adoption of AI in its energy sector. "I think the UAE has been an early mover in AI. I saw incred-

ible progress today in applying AI to their own energy system, and a big vision for where their future is going," Wright told reporters. He predicted significant cooperation between the two nations in both energy and AI, involving significant investments in both directions, along with continued geopolitical cooperation between the two countries.

In response to a question about mutual investments, especially following the launch of the UAE's XRG company, Wright explained that there are major opportunities for Emirati investments in the United States, as well as American investments in the UAE. These include flows of capital and technals with the UAE.

nology.

He added that artificial intelligence will drive the next phase of energy demand, particularly for natural gas and electricity.

Wright affirmed that his country is open to foreign investments and is working to empower the private sector and reduce costs, making it an attractive destination for investments in oil, gas, and advanced energy sectors.

He clarified that oil and gas prices are influenced by the forces of the free market and are not determined by any one party, noting that the US continues to produce oil at good levels, while natural gas production is growing rapidly, driven by rising domestic demand and increased export capacity.

He pointed out that short-term price fluctuations are mostly due to market perceptions related to supply and demand, saying: "In the long term, I believe we will see a gradual decline in oil and gas prices in the United States, and we hope this will also happen globally."



Wright clarified that this decline in prices does not necessarily mean a drop in company profitability, affirming that energy companies will continue to reduce production costs and face fewer government burdens, which will positively impact the sector. He emphasised that

President Donald Trump's agenda focuses on lowering energy costs as a means to improve citizen's living standards, boost corporate competitiveness, and increase investments. He noted that the current US administration aims to support energy demand growth through

the expansion of artificial intelligence, reshoring of industries, and raising living standards.

He also highlighted

new investment initiatives in the energy sector, including XRG, which focuses on investing in low-carbon energy, chemicals, enhancing technological innovation, and providing essential energy and products to improve the quality of life for individuals and communities worldwide.

He stressed that AI requires significant investments and advanced expertise, which provides fertile ground for strategic partnerships between the UAE and the United States.

Wright explained that capital and technology flows are moving in both directions, praising the level of technology used in oil and gas production, as well as the UAE's early investments

in artificial intelligence technologies.

He said the United States is preparing for a new phase of strong growth in demand for oil and gas in the coming years, in parallel with the expected increase in production, pointing out that artificial intelligence will be a key factor in this growth, particularly by driving up demand for natural gas and electric-

He noted that President Donald Trump is leading a trade agenda based on the principles of achieving balance in international trade and revitalising the manufacturing sector in the US, which contributes to creating local job opportunities and raising wage levels.

He explained that while the US has long been open to imports, its trading partners have not shown similar openness toward its exports. He added that the US

administration is seeking to achieve reciprocity, as well as to stimulate local industries through tools such as tariffs.

He noted that these policies will contribute to strengthening economic growth in both the United States and globally, despite the challenges that may accompany the transition phase.

Regarding relations

with China and Iran, he said preliminary negotiations are underway with China, expressing optimism about reaching an understanding that serves the interests of both countries.

He stated that the main objective regarding Iran is to end its nuclear programme, stressing the importance of serious negotiations and recognising the United States' commitment to preventing Iran from acquiring a nuclear weapon due to the threat it poses to the security of the Middle East and the world.

Desperate SRH aim to press reset button against **Punjab Kings**

Despite presence of seasoned campaigners like Pat Cummins, Mohammed Shami, and Harshal Patel, SRH have struggled to make early inroads

HYDERABAD, Apr 11 (Agencies): Desperate to arrest a worrying slide, Sunrisers Hyderabad will be eager to effect a turnaround when they host a power-packed Punjab Kings in their next IPL engagement here on Saturday.

Last season's finalists, SRH began their 2025 campaign on a thunderous note, racking up a mammoth 286 to dismantle Rajasthan Royals by 44 runs.

With an explosive batting line-up at their disposal, the 'Orange Army' seemed poised to become the first team to breach the 300-run mark but their ultra-aggressive approach has since backfired spectacularly.

In their last three matches, their attack-at-all-costs strategy with the bat yielded underwhelming totals of 163, 120, and 152 resulting in crushing defeats, and leaving them languishing at the bottom of the points table. They have worst Net-Run-Rate of -1.629 as of today.

With the bat, Sunrisers Hyderabad need far more from their big names like Travis Head, Abhishek Sharma, Ishan Kishan, and Heinrich Klaasen.

Head and Sharma, who played a crucial role in delivering explosive starts last season, have failed to find their rhythm this year. In fact, SRH's best opening stand so far is a paltry 15. Head's performance has



tailed off dramatically, returning scores of 67, 47, 22, 4, and 8. Abhishek, too, has struggled for consistency, with a top score of just 24 across five innings.

Kishan, after his unbeaten ton in the opener, has looked a shadow of himself, while SRH's middle-order mainstay Klaasen is yet to set the stage on fire.

Yet, the team appears committed to sticking with their aggressive blueprint. Head coach Daniel Vettori stressed on the need for better game awareness rather than a shift in philosophy after their last defeat.

"I think we know the style is going to work, but we have to respect conditions, and we have to assess really well and that's probably something we haven't done," Vettori said.

While SRH's misfiring batting

line-up has dominated postmatch discussions, their bowling unit hasn't exactly lit up the

tournament either.

The pace attack has failed to make any meaningful impact. Despite the presence of seasoned campaigners like Pat Cummins, Mohammed Shami, and Harshal Patel, SRH have struggled to make early inroads. The struggles continue into the middle overs, where they've failed to build pressure or claim key breakthroughs.

In stark contrast, Punjab Kings are riding a wave of early season momentum under the fresh leadership of Shrevas Iver.

The Indian star has led from the front with the bat and displayed impressive tactical thinking, guiding his team to three wins in four games as they sit at the fourth spot on the points

Adding to their firepower is young sensation Priyansh Arya. The rookie opener stunned fans and critics alike with a breathtaking century against CSK where most struggled to get going.

Meanwhile, Arshdeep Singh, Lockie Ferguson, Yuzvendra Chahal and Marco Jansen have done well in the bowling depart-

Speaking on the podcast, as posted by the Sky Sports Cricket X handle, Key said, "I cannot see him playing in the immediate future. So the whole point with

Ben is now he just actually Neil Colleen, our bowling coach (Neil Killeen, elite pace bowling coach), was working with him last week or a few days ago, and he started his bowling at 75 percent. And that's the focus.

Key also acknowledged that newlyappointed white-ball captain Harry Brook is keen on having someone of Stokes' level white-ball cricket but asserted for that, he will have to be in the "best condition physically and be able to get through".

"You know, he has not

played a game (Since the 2023 WC, tournament for which he returned from his ODI retirement taken during 2022). So our focus with Ben is that Zimbabwe test (May 22 onwards at Trent Bridge) and him getting ready and playing as that full role that he does. Not only is a brilliant captain, but batsman also being able to play as that fourth bowler, you know, play in that proper all-rounder role.

Key also said that if it all goes well, there is T20 World Cup in India and Sri Lanka next year and he could have a chance at it as well.

"But there is no point me sitting here now and saving that he will definitely be in that because there is so much cricket to go from it. But as far as we are concerned, no one's really out of it. If you are in if you are playing as well as you possibly can, if you are one of the best players in the country and you are fit and in the best condition possible, there is no reason why you cannot come in and you can do those things that Harry has sort of said, then anyone can come in." he concluded

BENGALURU, Apr 11 (Agencies): Royal Challengers Bengaluru mentor Dinesh Karthik conceded that his side has received a "challenging" pitch at the Chinnaswamy Stadium this season despite asking for a batting friendly surface, adding that the management will have a chat with the curator soon.

RCB's power-pa batting line-up was rendered ineffective on a sluggish deck in their two home games while getting restricted to 169/8 and 163/7 against Gujarat Titans and Delhi Capitals respectively, losing both the fixtures.

Karthik thinks the 22-yard strip has deprived RCB of the home advantage at a venue where matches have traditionally been high-scoring.

"In the first two games, we have asked for good pitches. But it's turned out in this way where it's been challenging to bat on. So, we try to do the best with whatever we get. But we will obvious-



ly have a chat with him (curator). We trust him to do his job," said Karthik in the post-match press conference.

"So, definitely, this is not a pitch that's helping the batters too much. It's a challenging pitch. So, that has been the case so far in both the games that we have played," he added.

Karthik said big hits and boundaries are an essential part of T20s, palatable to all stakeholders.

"I think the way T20 cricket is, the more runs there are, the better it is for the broadcaster. the better it is for the fans. They all like to see boundaries. And we will try and do the best of

what we can," he said. The former India wick

etkeeper batter said that while they try not to follow any particular template in a match, pitches such as the one at the Chinnaswamy made it tough for batters to even rotate the strike. "I think with every pitch, we'll try and understand what's the best way to play. I don't think we have one set template that is how we want to go out there and play. It's important to adapt

some shots and that has gotten the wicket of a few batters," he detailed.

Karthik said the slight drizzle mid-way during DC's innings helped the pitch settle down, which made the visitors' job that much easier.

"It was a bit sticky, the pitch. After the first four overs, and up until the 13th over, we were very much in the game. With the bat, we did have a wobble, but we found a way to get to a very decent score. They were struggling at 50 for 4."

"In the first game (vs GT), there was dew. So, it got a lot better to bat in the second innings. Today, there was not as much dew. Then, unluckily for us, a little bit of rain came."

"And then you could see the difference in the pitch. The shots that they played definitely weren't possible in the first innings," he explained.

Thus Karthik joins the likes of Lucknow Super Giants and Chennai Super Kings coaches Zaheer Khan and Stephen Fleming in expressing displeasure over the nature of pitches at their home stadiums.

After LSG's defeat to Punjab Kings, Zaheer had said the curator could have been from Punjab, while Fleming said CSK have not been able to read the pitch correctly for the last two seasons and his side has lost the home advantage.

Young leg-spinner Suyansh Sharma had a good 4-0-25-1 spell, and Karthik saw a bright future for him.

"Suyash, obviously, his average speed is probably slightly higher. But it has helped the wrist spinners in both the innings today."

"Suyash is one that is bound to play some higher cricket very soon with the skill sets that he possesses. I also feel the more revolutions you've given on this pitch, the better it has been for the bowlers," he said.

Bash champion, won 11 Women's National Cricket League titles and is the undisputed Women's Ashes champion as a five-time winner,


time on Sunday, July 6," said Perry.

"The state subject laws must return. The domicile regime must go. We will not stand by as our lands, culture, and employment are sold off like commodities," Dimple declared.

He accused the BJP

government of disregarding the will of the people, claiming that the party has handed over "lakhs of canals of land" to around 200 non-local investors for business purposes, fundamentally changing the demography of the erstwhile princely state. Citing survey reports, Dimple alleged that five lakh outsiders from states like Punjab, Delhi, Haryana, Uttar Pradesh, and Maharashtra have already settled in J&K, purchasing land and flats after the abrogation

of Article 370. Further lambasting the government's silence, Dimple criticized the Home Minister's recent visit, saying it bore "no promises, no roadmap, and no commitment" toward statehood. He accused RSS-BJP leadership of being the

"enemy of Maharaja Hari Singh's legacy," branding their actions a threat to Jammu's cultural soul. Dimple rejected the recently passed Waqf Bill, alleging it was a divisive ploy to stir communal tensions across India. He painted a stark picture of the current socio-political climate, accusing the BJP of behaving like the East India Company, exploiting J&K's natural resources, including mining and power sec-

With youth unemployment rising, Dimple called attention to 32,000 vacant government posts, claiming local talent is being ignored. He demanded the immediate waiving of electricity bills, 200 units of free power, and double rations including 12 LPG cylinders annually for every household. He urged LG Manoi Sinha and former CM Omar Abdullah to resume the traditional

The protest also condemned the chaos in the legislative assembly, with Dimple accusing BJP, PDP, and AAP MLAs of engaging in "gang war-like" behavior, a "murder of democracy," and ignoring the burning issue of state restoration
