Mock drill across border districts of J&K, Gujarat, Punjab, Rajasthan on **May 29**

NEW DELHI, May 28 (Agencies): Security drills will be held in border districts of states neighbouring Pakistan on Thursday, days after India launched Operation Sindoor, which targeted terror sites in Pakistan, as per TV reports. The mock drills will be held in Gujarat, Punjab, Rajasthan and Jammu and Kashmir, the reports stated.

India's first mock drill post 1971, on May 7 was followed that very night by the operation destroying terror launch pads across the border in Pakistan.

Three key objectives, political, military, and psychological were successfully achieved by India, through its military strikes.

Two drug peddlers arrested with heroin in **Udhampur**

UDHAMPUR, May 28 (Agencies): Two drug peddlers were arrested along with 5.7 grams of heroin from Chak Magiote in the Rehambal area of Jammu and Kashmir's Udhampur district on Wednesday, police said.

The duo has been identified as Sham of Kotli Pain and Simraan Khan of Jakhani, agency reported.

A case has been registered against the two under the Narcotic Drugs and Psychotropic Substances Act, a spokesperson said.

He said Sham was also wanted by police in multiple cases related to drug peddling and theft.

Neha Bhandari, Ione BSF officer who commanded border outpost along IB during Operation Sindoor


JAMMU, May 28 (Agencies): Commanding a border outpost within eyeball-to-eyeball contact of a Pakistani post along the International Border, Assistant Commandant Neha Bhandari led her troops to silence three forward hostile posts across the zero line (area closest to enemy territory) by giving a befitting reply.

Apart from Neha, six women constables held a gun position on a forward border post, with their 'josh' rising with every bullet they fired at enemy positions across the IB in Samba-R S Pura-Akhnoor sectors.

Neha, a third-generation officer from her family in Uttarakhand, takes pride in being part of the BSF and commanding a border outpost in the Pargwal forward area of the Akhnoor sector in the Jammu district during Operation Sindoor.

"I feel proud to be manning a post along the International Border with my troops. It is approximately 150 meters away from the Pakistani post in the Akhnoor-Pargwal area," Neha told agency



Her feelings are vivid as she confidently says that commanding the post during Operation Sindoor was an honour for her. "It was an honour to serve at the forward post and give a befitting reply with all available weapons from my post to enemy posts," she

Giving details of how she silenced three hostile posts resorting to unprovoked firing on her position during Operation Sindoor, she said, "I had three posts falling in my area. I pinned down the people at all three hostile locations. We hit them with every weapon we had. They were forced to flee their

posts."

The posts were decimated to ensure they were silenced, she said, adding that her troops performed their best during retaliation.

Expressing the high morale among the troops manning the post, she said, "The 'josh' was quite high. Everyone among us gave their best, because everything we did was for the country and its honour."

Neha's grandfather served in the Army, and her parents are from the Central Reserve Police Force (CRPF), making her a third-generation officer in the family. "My grandfather served in the Army. My father was in the CRPF. My mother

is in the CRPF. I am a third-generation officer in the force," she said.

She maintained that women did not lag behind, as they stood shoulder-to-shoulder with their male counterparts to give Pakistan a befitting reply during the three-day-long skirmishes.

"I had 18 to 19 women border guards with me. To be precise, six women were engaged in direct firing at observation post locations. We are proud of them," said Neha, who was the lone BSF woman officer to command a forward post along the IB in Jammu frontier during the opera-

Praising the role of women in combat at forward posts and their engagement in firing on Pakistani posts, Inspector General of BSF Shashank Anand said. "BSF women personnel played an outstanding role in this operation. Although they had the option to move to the battalion headquarters, they chose to stay at forward posts with their male counterparts and **Turn to page 9**

MHA, Ladakh leaders reach consensus, settle on 15-yr domicile rule



SRINAGAR, May 28 (Agencies): In a significant development, the Ministry of Home Affairs (MHA) and Ladakh leaders have reached a consensus on a 15-year prospective residency requirement, effective from 2019, to qualify for domicile status in the Union Territory of Ladakh. The agreement was described as the "Biggest Achievement" The meeting was chaired by Minister of State for Home Affairs, Nityanand Rai, held at North Block in New Delhi, The News Now reported.

The agreement has been hailed as the "biggest achievement" of the MHA-constituted High-Powered Committee (HPC) meeting. "It's a positive step that we have finally reached a

conclusion. The issue of domicile had been pending for a long time. Today's decision is the biggest achievement of the HPC meeting," said Chering Dorjay Lakruk, Co-chairman of the LAB, while addressing a press conference in New Delhi.

"We strongly advocated for a 30-year continuous residency in Ladakh as the criterion for domicile status. The government has assured us that it will examine the legal aspects of this demand and respond in the next meeting scheduled for next month". he added.

Ladakh leaders stated that the MHA also assured that it would consult the Law Ministry and legal experts "to examine the feasibility" of a 30-year residency requirement for domicile status—a key demand put forth by the Leh Apex Body (LAB) and the Kargil Democratic Alliance (KDA) during the meeting.

Sajiad Karqili, the KDA leader said, "Keeping in view the current scenario, our leaders from LAB and KDA unanimously decided that we should reach a conclusion. Both groups showed flexibility to reach today's consensus. We agreed to a 15-year continuous residency from 2019. However, we reiterated our demand for a 30-year domicile policy, which the MHA agreed to legally review. We also expect discussions on other core issues, such as a separate Public Service Commission (PSC), statehood, and inclusion under the **Turn to page 9**

The case came to light when Dharminder Singh, father of a 17-year-old boy, approached Chief Minister Bhagwant Mann with "evidence" of bribe demands by the Cyber Crime Police Station, Fazilka. The station had confiscated the minor's phone

following a complaint. Despite repeated attempts by the family to resolve the issue, they were forced to pay bribe to settle the matter.


Abdul Gani was taken into custody from the Maggar Khad area in

"The ripple effect of the April 22 Pahalgam terror attack has not spared Jammu. Katra, the gateway to Shri Mata Vaishno Devi shrine and one of the most visited pilgrimage destinations in the country, has seen a steep decline in pilgrim footfall. Jammu's prominent markets like Raghunath Bazaar, Gandhi Nagar, are struggling, hotels are witnessing mass cancellations, and the overall tourism economy is in distress. Yet, not a single high-level meeting has been planned in Jammu to assess the situation or provide reassurance to the stakeholders," he noted.

Gaurav Gupta emphasized that a true revival of tourism in J&K demands an inclusive and balanced approach.

"Jammu is not merely a transit point; it is a vital pillar of the UT's cultural and



spiritual tourism. From Katra to Patnitop, from historical temples to bustling markets—Jammu offers immense value to the tourism map of the region. The government must recognize this and act accordingly," he added.

He urged the Chief Minister to immediately convene a comprehensive review meeting in Jammu, involving senior administrative officials, representatives of the Shri Mata Vaishno Devi Shrine Board, hotel and travel associations, and local business leaders.

"Confidence-building measures must not be restricted to the Valley alone. Jammu too deserves the same attention, resources, and reassurance. Selective governance will only deepen regional imbalances and further alienate stakeholders," Gaurav Gupta asserted.

evelation and enumeration of caste in the country's census was not in the ideology and itinerary of the BJP right from the days of the Jan Sangh and so it was never issue for the new incarnation of Bhartiya Jansangh that is Bharatiya Janata Party .But now under the compulsion of vote bank politics and for political expediency, BJP has made a U -turn and has stated that caste enumeration will form part of the census operations in the country. BJP has made a volte face and has come a full circle so far as the caste census is concerned. It will not be an exaggeration to say that BJP has stooled caste issue from the opposition parties and has made the caste census in one of its main issues and with the inclusion of caste census in the political itinerary and the founding fathers of the Jansang / BJP will be uneasy in the heaven on seeing that its later incarnation BJP has included caste census in its agenda. However one side BJP tries to gain in terms of attracting votes of the Scheduled Castes, Scheduled Tribes and OBC's but on the other and more important side it is the moral triumph of the opposition parties including the bet nori Congress. The opposition parties like socialists ,Congress ,Leftists all were in favour of the caste census even from before the freedom of the country from British Yoke.But with the onset of independence of the country opposition parties bated for the caste census but it was not incorporated in the census of the independent India. Now that the BJP is in favour of the enumeration of the caste data in the upcoming census, it shows that under the political compulsion, BJP has stated that caste data will form a part and parcel of the census. In fact the BJP's decision has unsettled its ideological moorings while granting opposition parties a moral victory in their pursuit of social justice. For years together Opposition parties in the country have been advocating nationwide caste census and as against the right wing party BJP advocating Hindu unity has opposed and resisted such calls.But now all of a sudden in a surprising move, the BJP has now resolved to conduct a caste census alongside the population census which is in fact a U-turn of the saffron party which has been advocating and propounding Hindu unity and thus was the fiery critic of the caste census from very beginning. One wounders why this U-turn on the most important issue of caste census? It seems that theBJP under the compulsion of caste politics and for gaining the sympathy of the lower castes in the country, BJP has resolved to get caste data enumerated in the general census of the country. It seems the BJP is aiming to neutralize the Opposition parties who thrive on caste politics and BJP wants to wane away the lower caste votes from the Opposition parties and thus to take advantage of the caste politics. This shift of the BJP contradicts the philosophy of its ideological mentor the RSS.Now the question is how will the BJP reconcile with RSS on the issue of caste census which it has resolved to include in the general census of the nation. The latest shift in accepting the enumeration of caste data in the census militates with the core ideology of BJP,but the party is trying to encash votes by adopting the caste politics. All along BJP had been vociferously criticising the Opposition parties includ-

ing the Congress for their love for doing caste politics and highlighting the caste census demand.But now the most ardent critic of the caste census is stepping into the shoes of the Opposition parties and has in fact stolen this important issue from the Opposition parties and BJP does not feel any shame on doing the U-turn on the issue of the caste politics. It follows that for vote bank politics and political compulsion a party can stoop so low as is evidenced by the saffron party's neo love for caste politics and thus caste census. The caste yields significant impact on the political landscape of the parties in the states and so parties give much importance to those issues which are closely related with caste politics. Thus caste yields more impact upon politics than even religion and so the political parties across the spectrum give much importance and attention to caste politics and all the political outfits want to undo the others in the politics of the country. So electoral strategies hinge on caste affiliations and thus all political parties want to reap political dividends on caste politics. Mind last caste census was conducted along with the general census in 1931 in British India.In independent India in 2011 census UPA government initiated a Socio-Economic and Caste Census -SECC, but political manoeuvring prevented the release of its findings. After losing power, congress begun advocating for a caste census to further social justice and this was largely ignored by BJP.The RSS the ideological mentor of the BJP has consistently opposed caste census, saying it is more important to have Hindu unity than caste divisions in the nation. When RJD-JD alliance in Bihar conducted a caste census in 2023, BJP and RSS vehe-

mently objected to it. Similar exercises in Karnataka and Telangana faced criticism from the RSS and BJP accused these parties of fuelling caste -based vote politics.BJP and RSS said caste census should not become a political tool and must be conducted scientifically to address social inequalities. The decision to enlist caste enumeration in national census by BJP appears driven by political and electoral compulsions rather than being an ideological realignment of the saffron party. Some argue the announcement as a tactic to divert the attention of the gullible masses from the security lapse in the Pahalgam terror attack. Opposition parties including Congress, Samajwadi, left BSP and others mount pressure on the BJP as they push caste census agenda. This decision of the BJP may yield short terms electoral gains to the party but poses long -term challenges.Caste remains a dominant and formidable force in the Indian politics and so all parties are attracted towards caste politicking and BJP thought it fit not to lag behind and thus decided to the enumeration of the caste data in the general census of the country. In the end one can say that BJP made a U-turn from its earlier stand and stance and it also compromised its philosophy and core ideology at the altar of caste politics and thus decided for having a caste census in the country.

A knock of change in the language of justice

indi experiment in Rasntrapau ---on May 14 created a Rashtrapati Bhavan new history. The oath-taking ceremony of Justice Bhushan Ramakrishna Gawai became historic as the 52nd Chief Justice of the country. He started a new tradition by taking oath in Hindi. So far, all the Chief Justice has been taking oath in English only. Major personalities like the Prime Minister of the country, President, Vice President, Governor of the States and Chief Minister have already been sworn in in Hindi, but the highest post of the judiciary was untouched by it so far. Justice Gavai, who belongs to Vidarbha region of Maharashtra, broke that tradition by taking oath in Hindi and gave respect to Hindi, neglected in the judiciary so far. His decision is being welcomed by various social organizations. Using the mother tongue in her swearing-in, Justice Gavai has filled the lovers of millions of Hindi and other Indian languages of the country with a new hope. People hope that all Indian languages including Hindi in the judiciary under their leadership will receive due respect and space. It is ironic that hearing has been allowed in Hindi in the courts of the United Arab Emirates

(UAE) six years ago, while the

Supreme Judiciary of India is still limited to English today. Expectations from Justice Gavai are also because there are important rights inherent in his post. The language of proceedings in any High Court cannot become local without the consent of the Chief Justice. According to Article 348(1)(a) of the Constitution, the proceedings of the Supreme Court and all High Court will be done in English only. However, part (2) of the same paragraph also provides that if a state wants to do judicial work in its official language, the Governor can obtain the consent of the President and allow the use of Hindi or other official language of the state in the proceedings of the concerned High Court. Section 7 of the Official Language Act, 1963 also provides similar provision. Under this, the Governor, with the prior consent of the President, may permit English as well as Hindi or other ol use of the State for the judgment or orders of the High Court. Unfortunately, despite these constitutional and legal provisions, the use of them has been very limited till date. Under the provisions of the Constitution Hindi was to get permission to function throughout the country as an ol from January 26, 1965. But with sharp opposition against it, Tamil Nadu's Dravid politics jumped into

the ground. However, when he realised that it would not be appropriate to do so on Republic Day, he did so one day earlier i.e. on January 25. The Cabinet Committee was constituted for consideration ol policy because of such disputes arising out ol the ol who in his meeting dated May 21, 1965 decided that the consent of the Chief Justice of the country should be obtained on a proposal relating to the use of any language other than English in the High Court. In the eyes of Indian language lovers, this provision is the biggest obstacle in the way of becoming the language of justice of Indian languages. The functioning permit in Hindi under the Samvidhanik provision was first achieved to Rajasthan, which was allowed to take action in Hindi in 1950. Hindi proceedings were allowed in the Allahabad High Court in 1969, while Madhya Pradesh received 1971 and Bihar in 1972. There are many states that asked for permission to take action in their high court in their languages from time to time, but they only got failure. Although the enthusiasm of Indian language lovers did not diminish despite all the constitutional provisions and their hindrance. They have been demanding Indian languages to form the language of judiciary. It has also affected the higher judiciary. Of

course judicial proceedings are not happening in Indian languages, but the jurisdiction has moved towards making smooth access to common people till decisions and judicial proceedings. Under this, the proceedings and decisions are being promoted to translation from English to regional languages. The Supreme Court has constituted an AI assisted legal translation advisory committee under the chairmanship of Justice Abhay S Oka. Through this, thousands of decisions, etc., are being translated in 16 languages so far. Like Oka committee all highcourts have also made committees for their translation here. The Bar Council of India under the Ministry of Law and Justice has taken place before the former Chief Justice of the country, Justice S.A. Bobde chaired by 'Bharatiya Bhasha Samiti' has also formed. This committee is developing a similar vocabulary for all Indian languages with an aim to translate legal content into regional languages.

Stardom's evil partner is arrogance; hard to stay grounded: Kamal Haasan

In his film career spanning over 65 years, Kamal Haasan has done it all: acting, direction, scriptwriting, choreography and even makeup. Anything left to do?

Many things. But, he declares (without a hint of false modesty), that he stopped learning at some point. Oh! Why? "Avarice," he replies.

Greed for more money got in the way, he says. "I like money. I want it to come to me," Haasan told agency in an interview this week.

In one of his most candid conversations about life, films, AI, philosophy, legacy and his frailties, Haasan acknowledges the inherent contradictions of a movie star's life: the joy of reaching a "larger demographic" and the regret of not receiving real applause or honest criticism.

He should know, having been in the business almost all his life. He was just three years old when he got a role in a Tamil movie. Since then, barring a few hiatuses, the 70-year-old has been constantly reinventing himself to stay in step with the changing times.

After that extraordinary career and achieving all this, does he feel like patting himself on the back and saying 'well done Kamal'?

Haasan's reply makes it clear that he sees success as ephemeral.

"My favourite writer

Jayakanthan says 'Once you climb Everest, don't stay on top because there is no place (to stay). Then you will cling on to it and won't let anyone else climb it'. And you become eccentric, literally, because you're not at the centre of people," Haasan, a self-confessed admirer of the news business, said in the interview after touring the news agency's headquarters.

It can also be lonely at the top, said the consummate heart-tugger who bridged the north-south cinematic divide early in his career when pan-India was decades away from being a buzzword.

The star of films such as "Apoorva Raagangal", "Nayakan", "Thevar Magan", "Sadma", "Pushpak Vimana" and "Chachi 420", each different in mood and treatment, is now getting ready for his latest ven-

ture "Thug Life", directed by Mani Ratnam and set for theatrical release in multiple languages on June 5.

The actor, who started a political party like many other stars from the southern film industry, has also directed a range of films, including "Hey Ram" and "Vishwaroopam". He said frankly that it is very difficult for stars because the inner circle is always trying to carry them aloft and not let their "feet touch the ground".

"The beauty of cinema is that you can reach a larger demographic but it also takes you away from the actual witnessing of your applause. So, you distance yourself and arrogance sets in because you don't hear criticism, nor do you hear applause. It all comes through reporting to us, or when you meet your fans and they cheer you, but that's not the actual data," he added.

As someone who has been in the film industry for more than half of Indian cinema's 120-year existence, Haasan is quick to downplay his achievements and speaks about his early years with rare candour.



"Because of my work schedule, I stopped seeking more gurus. I think my avarice for money stopped me from learning. Otherwise, I would have learned

more."

Affluence, according to Haasan, is what people dream of in their 20s and he was not that different. "I pursued that path for quite some time at peril to my heart. Then I woke up and started my own company. Fortunately, I did that before I became 30. It was a risky thing to do."

What does Haasan

want someone going through a cinema history book in 2075 to read about him?

Let alone a mention in history books, he would be grateful if anyone even remembers him 50 years hence, he said.

"I hope they remember my name. They'll confuse me for some other guy, and I will take his credit for no reason. After some time, people vaguely say, 'Who did that film?' Was it Buster Keaton or Chaplin?"

"...I'm going to be lost in that crowd, and I'm happy to be (lost), as long as someone with a microscope is looking for me and still finds me."

Haasan describes himself as a child of cinema. When he was a little over five, he won the Presidential Medal for his performance in the 1960 film "Kalathur Kannamma".

Six decades and more later, he is a superstar loved by the masses, a director who has proved his mettle, a producer, one of the finest classical dancers among actors, lyricist, storywriter and always a seeker, who spent three months in the US last year to educate himself about artificial intelligence.

The superstar, who grew up with a lawyer father taken in by the ideas of Mahatma Gandhi and changed his children's surname to 'Haasan', said he thought of himself as an "extraordinary and gifted child"

"That is a complacency that went away when I was seven or eight. I realised that there are many more talented children who could have eaten me for breakfast. That's when I panicked. I don't know whether

to call it graduation or experience or immersion but from cinema I went to theatre."

"Usually, it is the other way around. So that's when I met other talented people. At first, I suffered from an inferiority complex, and then they accepted me and I realised I have to keep

learning more," he said.
Haasan is currently
on a promotional blitzkrieg for "Thug Life",
which reunites him with
Mani Ratnam 38 years
after "Nayakan", the cult
gangster classic.
The actor, who has

also produced the movie through his production house Raaj Kamal Films International alongside Ratnam's Madras Talkies, said it was a mistake they did not collaborate all these years.

"At first we wanted to (but) we were apprehensive about how this will turn out and how all eyes are on us. We were scared. I thought, 'Let them forget 'Nayakan' and then we'll make another. And they refuse to forget 'Nayakan'. That's one of the reasons why it got delayed," he said, adding they both had

their companies to run.
Who gets the final say if there are any creative differences?

"We never set the rules of the game," Haasan responded. Their 44-year friendship, he added, helped them develop a shorthand that made people on the set believe they had already

rehearsed the scenes. In a career of more than 230 films, Haasan said there are only a dozen or so films he considers among his best. Included in this are his performances in "Sagara Sangamam" and "Nayakan".

Both films still make him cry.

"Public confession? Yes, I do. It doesn't matter whether it's Kamal Haasan or any other actors, if the scene is pertinent and touches me, I can... There are films like that, they'll make you cry after 40 years, 50 years."

Has the ever busy star ever thought of taking a back seat?

"That age will tell me, achievements won't. They may not even convince you. Age will convince you, it's yet to convince me," he said.

Sandeep Reddy Vanga slams actor for 'playing dirty PR games'

Filmmaker Sandeep Reddy Vanga, known for "Animal" and "Kabir Singh", shared a cryptic post on his social media, calling out an actor for playing "dirty PR games".

Without taking any names, Vanga posted a lengthy tweet on his X handle.

"When I narrate a story to an actor, I place 100 per cent faith. There is an unsaid NDA (non-disclosure agreement) between us. But by doing this, you've 'DIS-CLOSED' the person that you are....Putting down a younger actor and ousting my story? Is this what your feminism stands for," the post began.

"As a filmmaker, I put years of hard work behind my craft and for me, filmmaking is everything. You didn't get it. You won't get it. You will



never get it. Aisa karo.... Agli baar poori kahani bolna... kyunki mujhe jarra bhi farak nahi padtha. #dirtyPRgames. I like this kahawath very much...Khundak me billi khamba noche," he added.

This comes days after he announced taking Tripti Dimri as a female lead in his upcoming

film "Spirit", which also stars Prabhas. Reportedly, Deepika Padukone was supposed to be in the project but exited it.

"Spirit" reunites Vanga with Dimri, who have previously worked together in "Animal" (2023). It is produced by Bhushan Kumar's T-Series and Vanga's Bhadrakali Pictures.

Born in 1883 in Maharashtra, Savarkar was



a proponent of revolutionary methods to gain freedom from the British empire before his imprisonment in the Andaman Islands under extremely punishing conditions.

A hero to Hindu nationalists, he is credited with

developing the political framework of Hindutva and was a prolific author and poet.

Criticised by secular parties like the Congress for his advocacy of Hindutva, Savarkar has been a venerable figure for the ruling BJP.

SC extends interim bail to Ashoka University professor, says no impediment on right to speech

NEW DELHI, May 28 (Agencies): The Supreme Court on Wednesday told Ashoka University professor Ali Khan Mahmudabad, accused of making contentious social media posts on Operation Sindoor, that there was no impediment on his right to speech and expression, but he can't post anything online with respect to the cases against him.

A partial working day Bench of Justices Surya Kant and Dipankar Datta refused to modify as of now, the interim bail condition imposed on him on May 21 that he will not write any online post, article or make any oral speech related to either of the two online posts, which are subject matter of the investigation.

The top court had also restrained the professor from expressing any opinion in relation to the terrorist attack on Indian soil or the counter-

response given by the Indian Armed Forces.

The Bench said it is extending the interim bail granted to the professor and directed the SIT to furnish the investigation report on the next date of hearing.

The top court made it clear that the subject matter of investigation was two FIRs lodged against the professor and asked the Haryana Police not to go "left and right" in the investigation and seek the "devices", which the cops said they would like to examine.

The Bench also asked the Haryana Police to apprise it about their response to the NHRC notice on registration of FIR against the professor.

On May 21, the National Human Rights Commission (NHRC) said it has taken "suo motu cognizance" of a media report in connection with the arrest.

The rights panel has noted that "the report, which contains a gist of the allegations based on which he has been arrested, discloses, prima facie, that the human rights and liberty of the said professor have been violated".

On May 21, the top court granted interim bail to the professor, who was arrested for his contentious social media posts on Operation Sindoor, but refused to stay the investigation against him.

It had directed the setting up of a three-member SIT to look into the FIRs lodged against him.

Haryana Police arrested Mahmudabad on May 18 after two FIRs were registered against him. His contentious social media posts on Operation Sindoor, it is alleged, endangered the sovereignty and integrity of the country.

The two FIRs -- one based on a complaint by the chairperson of Haryana State Commission for Women, Renu Bhatia, and the other on a complaint by a village sarpanch -- were lodged by Rai police in Sonipat district.

"On the Commission chairperson's complaint, the FIR has been lodged against Professor Ali of Ashoka University under BNS sections 152 (acts endangering sovereignty or unity and integrity of India), 353 (statements conducing to public mischief), 79 (deliberate actions aimed at insulting the modesty of a woman) and 196 (1) (promoting enmity between different groups on grounds of religion)," police said.

Several political parties and academicians have condemned the arrest.

Chennai court finds accused guilty in varsity student sexual assault case

CHENNAI, May 28 (Agencies): A Mahila Court here on Wednesday pronounced as guilty A Gnanasekaran, the biriyani vendor arrested in the sensational Anna University woman student sexual assault case, with the prosecution seeking "maximum punishment" for him

Holding that the prosecution has proved the case beyond reasonable doubt, the court found Gnanasekaran guilty of the charges framed against him in the sexual assault case that rocked Tamil Nadu in December 2024

Mahila Court Judge Rajalakshmi said she will pronounce the verdict on June 2.

The government coun-

sel later told reporters that the prosecution filed 11 charges against Gnanasekaran and proved all of them using documentary and forensic evidence.

"Today, he was pronounced guilty by the court. The details of the sentence will be given on June 2," she said.

Giving a brief update on the proceedings on Wednesday, she indicated that Gnanasekaran sought a lenient sentence claiming he was the sole bread-winner of the family.

"The prosecution strongly objected to this and sought the maximum punishment," she added.

The sensational case had triggered a political row over Gnanasek-



aran's alleged connections with the ruling DMK in the state, although the party president and Chief Minister MK Stalin had in January said he was only a sympathiser and supporter, and not a member of the Dravidian party.

The case came to light after the victim lodged a complaint before the All

was downloaded from the CCTNS website of Tamil Nadu police and broadcast by certain sections of the media which created a furore.

Later, the Madras High Court transferred the investigation of the case to a Special Investigation Team, which also probed the FIR leak.

The SIT filed a charge sheet in February before a magistrate court. Thereafter, the case was transferred to the Mahila Court.

The Mahila Court framed charges against Gnanasekaran under various sections of the BNS, including sexual harassment, BNSS, IT Act and the Tamil Nadu Prevention of Women Harassment Act.

THANE, May 28 (Agencies): A 73-year-old woman from Maharashtra's Thane district has been allegedly cheated of more than Rs 57 lakh by a man who promised to marry her, police said on Wednesday.

The victim, resident of a housing society on Nana Shankarshet Road in Dombivli area, got in touch with the 62-year-old man through his matrimonial advertisement published in a newspaper, Vishnu Nagar police station inspector Vivek Kumutkar said.

After gaining the woman's confidence, the man promised marriage and a peaceful

life together in Pune, he said.

"The man told the victim that he intended to buy a house in Pune and convinced her to transfer Rs 35 lakh for it. He gave her fabricated receipts and fake property documents to assure her," the official

said.

After temporarily living at the woman's house, the accused also allegedly stole her gold ornaments valued at around Rs 20 lakh. He also allegedly stole her debit card and used it to withdraw Rs 2.4 lakh, according to the police.

After duping the woman of her funds last month, the accused

According to the police, the survivor alleged in her complaint that while she was in an empty classroom for a call, the dean allegedly

The half-burnt body of the man from Jakhotra village in Santalpur taluka of Patan was recovered on Tuesday night, following which the police nabbed Geeta Ahir (22) and her lover Bharat Ahir (21) in the early hours of Wednesday from Palanpur railway station, an official said.

The accused woman told the investigators that she hatched a conspiracy to fake her own death after getting inspired by "Drishyam" film, he said.

Addressing a press conference, Patan Superintendent

of Police (SP) V K Navi said. "Geeta, who lives with her husband at Jakhotra, came up with this plan and convinced her lover to arrange a dead body so that they can fake her death and live together after fleeing from Gujarat." On Tuesday night, Geeta left her house when everyone was asleep. Later, when her husband and other family members were searching for her, they found a halfburnt body lying near a pond on the outskirts of the village, Nayi said.

"Since Geeta's 'ghagra' (long traditional skirt) and her anklets were found on the body, her kin initially thought that it was Geeta's body. However, after bringing the body home, they found that the deceased was a man. After being informed about it, we registered a case of murder and

launched a probe," the SP said. The dead person was later identified as 56-year-old Harjibhai Solanki, who used to live

a nomadic life at neighbouring Vauva village in Santalpur taluka, according to Nayi.

After coming to know that Geeta was in love with Bharat and both might flee to Rajasthan by train, a police team nabbed both of them from Palanpur rail-

by train, a police team nabbed both of them from Palanpur railway station, where they were waiting for a Rajasthan-bound train, the SP said, adding that both of them admitted to their crime.

"Geeta told us that since she had seen "Drishyam" as well

"Geeta told us that since she had seen "Drishyam" as well as "Drishyam 2" movies, she came up with this plan to fake her death so that she can spend the rest of her life with Bharat, who agreed to act as per her plan and started searching for a

man or a woman for murder. On May 26, he spotted Solanki and offered him a lift on his motorcycle," the SP said.

Bharat stopped his vehicle at a secluded place and killed Solanki by strangling him before taking the body near a pond at Jakhotra, the official said.

As planned, Geeta fled her house on Tuesday night when everyone was asleep and reached the spot with a bottle of petrol, said Nayi.

"They first put Geeta's ghagra as well as anklets on Solanki's dead body, and set it on fire using petrol brought by her. They fled from the spot and reached Palanpur railway station as they had planned to go to Jodhpur by train. However, our team nabbed them from the spot," Nayi said.

Odisha man kills 2 by sending parcel bomb as wedding gift, gets life term

BHUBANESWAR, May 28 (Agencies): A lecturer was sentenced to life imprisonment by a court in Odisha's Bolangir district on Wednesday for killing two persons, including a groom, by sending a parcel bomb as a wedding gift.

Punjilal Meher, a lecturer at Jyoti Vikas College in Bhainsa, had a professional enmity with the groom's mother at the college where she worked as the principal. Due to this reason,

Punjilal hatched the conspiracy to kill her son Soumya and sent the bomb as a wedding gift in 2018, the police said.

The Patnagarh Additional District Judge (ADJ) court has convicted the accused Punjilal Meher in the case and sentenced him to life imprisonment, government counsel Chittaranjan Kanungo said.

The court convicted him under Sections 302 (murder), 307 (attempt to murder) and 201 (destroy evidence of a crime) of IPC and Sections 3 and 4 of the Explosive Substances Act, he said.

The court sentenced life imprisonment under two sections, 10 years of imprisonment under two charges and seven years imprisonment under another charge. Kanungo said that all the sentences would run concurrently.

"Our submission was to treat it as a rarest of rare cases.



However, the court did not observe it as a rarest of rare cases because all heinous crime cases cannot be treated like

that," the public prosecutor said.

He said the quantum of punishment pronounced by the court is very encouraging. It will give a positive message to the society at large.

The court also imposed a fine of Rs 1.70 lakh on the convict.

He will remain behind bars for the rest of his life, Kanungo informed media persons outside the court.

Soumya Sekhar, a man in his mid-twenties, and his 85-year-old grandmother were killed in the blast.

His wife, Seema Sahoo, suffered critical injuries when a parcel bomb, disguised as a wedding gift, exploded at their Patnagarh home in Bolangir district on February 23, 2018.

The blast had taken place when the groom opened the gift.

Following a request by the new bride and her family, the then chief minister Naveen Patnaik had ordered the Crime Branch to probe into the

incident.

The Crime Branch took over the investigation

on March 23, 2018, and arrested Meher in April 2018.

He is currently lodged in the Patnagarh subjail. The Crime Branch, in

its charge sheet, has accused Punjilal Meher an English lecturer at the college where the victim Soumya Sekhar's mother Sanjukta Sahu was the principal.

The investigating agency has said that revenge was the motive behind the crime.

"World War 3": Ex-Russian President warns Trump after Putin's criticism

MOSCOW, May 28 (Agencies): Former Russian President Dmitry Medvedev has warned Donald Trump of World War III after the US President said his Russian counterpart, Vladimir Putin, was "playing with fire" by continuing the war with Ukraine.

The threat came as Trump said he would "absolutely" consider new sanctions on Moscow amid missile and drone bombardment in Ukraine that left many dead.

"Regarding Trump's words about Putin "playing with fire" and "really bad things" happening to Russia. I only know of one REALLY BAD thing - WWIII. I hope Trump understands this!" Medvedev said in a post on X.

Medvedev served as Russia's President of Russia between 2008 and 2012 and Prime Minister between 2012 and 2020.



Trump's Frustration With Putin Trump's frustration at his failure to end a war he said he could solve within 24 hours boiled over the weekend after Russia's drone barrage killed at least 13 people. Diplomatic efforts to end the war have intensified in recent weeks, but

Putin has been accused of stalling peace talks.

On Tuesday, he warned Putin of serious consequences, saying, "What Vladimir Putin doesn't realise is that if it weren't for me, lots of really bad things would have already happened to Russia, and I mean REALLY

BAD. He's playing with fire!"

Though Trump did not specify what the serious consequences would be, the Wall Street Journal and CNN both reported that the Republican was now considering fresh sanctions as early as this week. Trump told reporters on Sunday he was "absolutely" weighing such a move.

Meanwhile, Moscow, which invaded Ukraine in February 2022, did not react to Trump's comments on Tuesday, but it had earlier sought to blame Ukraine for the impasse.

Moscow insisted it was responding to escalating Ukrainian strikes on its own civilians and accused Kyiv of trying to "disrupt" peace efforts. Russian authorities said almost 150 Ukrainian drones had been intercepted, including 33 heading toward Moscow.

Israeli military claims it did not open fire on crowds at Gaza aid distribution point

JERUSALEM, May 28 (Agencies): The Israeli military on Wednesday said soldiers did not fire at civilians at an aid distribution point in the Gaza Strip the day before, after a United Nations official reported numerous gunshot wounds

"We are checking information from the UN. At the time we are speaking, we have no information on this matter," military spokesman Colonel Olivier Rafowicz told agency, referring to the wounded civilians.

Israeli soldiers "fired warning shots into the air, in the area outside" the centre managed by the Gaza Humanitarian Foundation (GHF), he said, adding that "in no case (did they fire) towards the people".

Rafowicz added that "Hamas is doing everything to prevent humanitarian aid".

Ajith Sunghay, the head of UN Human Rights Office in the Palestinian territories, said on Wednesday that "about 47 people were injured" on Tuesday when thousands of Palestinians rushed toward a new aid distribution centre in Rafah in the southern Gaza Strip.

"Most of the injuries were caused by bullets," and "the shots came from the Israeli army", he said.

According to agency journalists at the site. thousands of Palestinians rushed toward the centre being managed by the GHF, an organisation created with the support of the United States and Israel to distribute aid inside the Gaza Strip.

The United Nations and international aid agencies have declared they will not cooperate with the GHF, which has been accused of working with Israel without any Palestinian involvement and bypassing the UN.

"We have raised numerous concerns with this mechanism," Sunghay said.

"What we saw yesterday is a very clear example of the dangers of distributing food under the circumstances which the Gaza Humanitarian Foundation is doing."

Indonesia, France call for Gaza ceasefire, unimpeded humanitarian access

JAKARTA, May 28 (Agencies): Indonesian President Prabowo Subianto and visiting French President Emmanuel Macron on Wednesday called for an immediate halt to hostilities in Gaza and unimpeded access to humanitarian aid.

President Prabowo welcomed Macron at the State Palace, where the two leaders discussed a range of issues.

"We agreed to coordinate with each other in upholding respect for international law," President Prabowo said during a joint press conference following their meeting.

According to Prabowo, both leaders reaffirmed their commitment to supporting efforts



toward Palestinian independence as a sovereign state.

"Indonesia views only a two-state solution, the independence of the Palestinian nation. as the only way to achieve lasting peace," he stated.

Prabowo emphasised that Indonesia would recognize Israel's sovereignty and establish diplomatic relations if Israel acknowledges Palestine's independence.


Both Indonesia and France, as conveyed by Prabowo, urged Israel to open the widest possible access to Gaza, allowing humanitarian aid to reach those in need.

Taiwan slams China's Cross-Strait summits as 'United Front Lectures,' shuns events in Beijing

TAIPEI, May 28 (Agencies): Taiwan's Mainland Affairs Council (MAC) criticised China on Wednesday for organising two summits for Taiwanese participants later this week, claiming these gatherings aim to "lecture" rather than promote authentic exchanges across the Taiwan Strait, as reported by Focus Taiwan.

The MAC stated that

the upcoming summits are "conducted under the guise of cultural and media exchanges aimed at summoning Taiwanese media and cultural figures to Beijing for lecturing and instruction." The council emphasised that these events do not embody the essence of true cross-strait cultural and educational exchanges and are "not supported by the Taiwanese government".



The council remarked that the Chinese Communist Party's (CCP) utilisation of various forms of exchanges as tools for united front work does little to bridge differences across the Taiwan Strait and will not earn the acceptance of Taiwanese society, as highlighted by the Focus

Taiwan report.

The two summits mentioned by the MAC are the second Cross-Strait Chinese Culture Summit and the sixth Cross-Strait Media Summit, which are set to commence in Beijing on Wednesday and Thursday, respectively. Before the official start of these

events, a Taiwanese delegation of around 30 individuals, including former Kuomintang Chairperson Hung Hsiu-chu, was greeted on Tuesday by Wang Huning, chairman of the National Committee of the Chinese People's Political Consultative Conference in Beijing.

Wang stated during the reception that Chinese culture represents "the root and soul of the Chinese people on both sides of the Taiwan Strait," and called for collective efforts to "unite and strive for the great rejuvenation of the Chinese nation".

The Taiwan-China issue presents a complex and enduring geopolitical conflict centred on Taiwan's sovereignty. Taiwan, formally known as the Republic of China (ROC), operates an independent government, military, and economy, effectively functioning as a self-governing

Conversely, China regards Taiwan as a breakaway province and insists on the "One China" principle, which declares that there is only one China, with Beijing as its capital. This stance has led to decades of tension, particularly since the Chinese Civil War (1945-1949), when the ROC government retreated to Taiwan after the Communist Party, led by Mao Zedong, assumed control of mainland China.

Beijing has consistently voiced its ambition of reunifying with Taiwan, employing diplomatic, economic, and military pressure to marginalise Taiwan on the global stage.

Iran executes man convicted of spying for Israel, activists slam 'unfair' trial

Activists and his family said that the case against him was deeply flawed and he had notably been denied the right to a lawyer of his choosing during the legal process.

PARIS, May 28 (Agencies): Iran on Wednesday executed a man convicted of spying for Israel, in defiance of pleas from his family and activists for his life to be spared after what they described as an unfair trial.

Pedram Madani, 41, was hanged in Ghezelhesar prison in Karaj outside Tehran after earlier this week being transferred from Evin prison in the capital where he had been held following his arrest in 2019.

He is the second man to be executed by Iran on charges of spying for Israel within two months, amid a surge in executions on all charges which activists say is aimed at instilling fear in the population.

The hanging comes against the background of a new period of escalating tensions between Iran and Israel, which the Islamic republic does not recognise, over the Iranian nuclear programme.

The judiciary's Mizan Online website said Madani had been

"spying in favour of the Zionist regime", using the term employed by institutions in the Islamic republic to denote Israel.

"Following the complete process of criminal procedure and the final confirmation and upholding of the verdict by the Supreme Court. he was brought to justice and executed," it

Unfair process

Madani "was sen-

tenced to death by the Revolutionary Court without access to a lawyer of his choice. through an unfair and non-transparent process orchestrated by security agencies," Mahmood Amiry-Moghaddam, the director of Norwaybased NGO Iran Human Rights (IHR) which tracks the death penalty in Iran, told agency.

"The Islamic Republic's goal in executing Pedram Madani and



others who are hanged daily is solely to instill fear within society and to conceal the regime's widespread corruption and systemic failures."

The Dadban legal monitor said in a statement on social media that in such a trial before a Revolutionary Court the defendant is denied the possibility of defending himself and the judge also has "no option" of rejecting the case.

"It is more than a legal accusation -- it is a charge used as a tool to issue and carry out the death penalty," it said.

In a video posted on Tuesday by IHR and other groups warning of the risk of the imminent execution, his mother described Madani as a "man who loves his country and loves his family."

"My son's case is full of flaws and his death sentence must be revoked,"

she said False confessions There had on the eve

of the execution been numerous pleas from Iranian campaigners for his life to be spared, including from Nobel peace prize winner Narges Mohammadi, currently on temporary release from serving her own prison sentence.

"The Islamic republic uses the death penalty as a tool to instill fear and intensify repression against the people," she said in a video state-

"There was not even a chosen lawyer on the case. Pedram's cellmates testify he confessed falsely and under pressure. In Revolutionary Courts these false confessions serve as

the basis of death sentences," she added.

According to 'Mizan' Madani was accused of transmitting classified information and holding meetings with Mossad officers abroad, including in Brussels.

The judiciary said he had travelled to "the occupied territories" -- the term used by Iranian officials to describe Israel -- prior to his arrest in 2020-2021.

He was also convicted of acquiring "illicit wealth" by receiving euros and bitcoin from Israel.

In April, Iran executed Mohsen Langarneshin for allegedly aiding Mossad in the 2022 killing of an Islamic Revolutionary Guards colonel in Tehran.

Rights groups including IHR have said Langarneshin was executed after an unfair trial and a confession extracted under torture.

According to IHR, there have been at least 478 executions in Iran this year alone, including more than 60 hangings in the last 10 days.

Sri Lankan authorities seize 600kg of heroin and meth in major drug bust



COLOMBO, May 28 (Agencies): Sri Lankan authorities have reportedly seized more than 600 kilograms of heroin and crystal methamphetamine in a major maritime drug bust, arresting 11 suspects and confiscating two fishing trawlers used in the smuggling operation.

The interception occurred during a joint operation conducted by the Sri Lanka Navy, State Intelligence Service, and Police Narcotics Bureau in the country's southern territorial waters. The two vessels were escorted to Dikowita Fisheries Harbour on Wednesday, where both the drug consignment and suspects were formally taken into custody.

According to the Sri Lankan Navy, initial assessments confirm a haul exceeding 600 kg, though final verification is on. The seized drugs - heroin and methamphetamine (locally referred to as "ice") - were hidden aboard multi-day fishing trawlers commonly used in maritime trafficking routes, reports News

First. Sri Lanka has long faced international drug smuggling challenges, owing to its strategic position in the Indian Ocean. The island nation has often been used as a transit point by crime syndicates for regional, as well as international drug smuggling.

In response, Colombo has intensified its crackdown on narcotics operations in recent years, increasing surveillance, and jointly collaborating with Indian intelligence and Naval authorities for seizing drug consignments.

Deputy Defence Minister Aruna Jayasekara, who inspected the seized contraband alongside senior security officials, pledged firm legal action against the traffickers. "This is part of our commitment to building a drug-free society," he said.

The suspects and contraband have been handed over to the Police Narcotics Bureau for further investigation and legal proceedings.

This latest bust marks one of the largest in recent memory and underscores Sri Lanka's growing role in regional anti-drug trafficking efforts, as authorities continue to confront sophisticated smuggling networks exploiting the island's vast coastline.

Pant's calibre and ability was never in doubt: LSG mentor Zaheer



LUCKNOW, May 28 (Agencies): Lucknow Super Giants mentor Zaheer Khan has asserted that skipper Rishabh Pant's calibre and ability were never in doubt despite his underwhelming performances for most of the IPL season. Khan also said that the charismatic stumper will emerge stronger after this learning curve.

Bought for a whopping Rs 27 crore at the mega auction, Pant endured a lean patch, managing just 269 runs from 13 innings. He found his trademark big-hitting touch only in the last game of the season with a 61-ball 118 but that too ended up in a losing cause against Royal Challengers Bengaluru here.

"He's been good as a leader. That was a positive for us throughout the season. The form with the bat was defi-

nitely a learning experience for him, having this kind of season."

"But the ability and calibre-no one had any doubt about it," Zaheer said in the post-match press conference.

The former India pace spearhead said it was good to see the swashbuckling keeper-batter end the season on a high.

"We're happy he finished on a really strong note - that's the calibre he has, and the impact he can have on the game," Zaheer added.

It was a disappointing season for LSG, who finished seventh with six wins and eight losses. A spate of injuries to key bowlers disrupted their rhythm and consistency.

"When you start off the IPL season, your first goal is to think of the playoffs, how you are going to get there...We obviously made the conscious effort of (trying to handle) the challenges which we are facing in the beginning of the season, which is losing a few of our main bowl-

ers to injuries," he said. "We made an effort to not pay too much attention to that ... and finding ways of winning the

match," Zaheer said. "That is the process which everyone was aligned to and looking at that, we have had a decent season...but yes, we fell short and putting the game together was a challenge which was evident right through the season...," Zaheer said.

Despite the bowling woes, Zaheer said the stability in the batting unit was a major positive. The overseas trio of Aiden Markram, Mitchell Marsh, and Nicholas Pooran—the team's standout performer with the bat—brought solidity to the line-up.

"There are positives, a lot of positives—the stability was evident with regard to batting.

"But with regard to bowling, we were trying to figure out the combinations, we were trying to figure out the options which can get us over the line and that is something that was the story right throughout the season," he conceded.

Satwik-Chirag make winning return; Lakshya retires hurt

SINGAPORE, May 28 (Agencies): India's top men's doubles pair of Satwiksairaj Rankireddy and Chirag Shetty made a winning return, while there was heartbreak for Lakshya Sen, who was forced to retire midway through his opening round clash at the Singapore Open Super 750 badminton tournament here on Wednesday.

India's no 1 singles player Sen was forced to retire hurt during his openinground clash against Lin Chun-Yi of Chinese Taipei.

Sen, currently ranked 17th in the world, started strong and took the first game 21-15. But his opponent, world



No. 19 Lin, bounced back to claim the

India series will be real test for Crawley, Pope: **Geoffrey Boycott**

LONDON, May 28 (Agencies): Legendary Geoffrey Boycott remains unconvinced that England's Zak Crawley and Ollie Pope have overcome their "technical and mental issues" despite scoring centuries against Zimbabwe, insisting that their real challenge will come in next month's five-Test series against

Crawley has endured a tough few months, struggling in New Zealand where he averaged under nine and fell to Matt Henry in all six innings.

Pope, too, had a rollercoaster 2024. His brilliant 196 in the opening Test against India in Hyderabad stands among the finest overseas knocks by an Englishman, but he has been extremely inconsistent since.

"We cannot say suddenly that Crawley and



Pope have solved the technical and mental issues that have dogged their careers because the Zimbabwe bowling was so average," the former English opener wrote in his column for the 'Daily Telegraph'.

England's top-three of Crawley, Ben Duckett, and Pope all struck dominant hundreds as the hosts piled up 565/6 declared against what Bovcott termed a Zimbabwean "club-bowling" attack, en route to an innings and 45-run victory in the recently concluded one-off Test.

"They were medium pacers not good enough or consistent enough to expose any flaws in Crawley and Pope's batting. We will have to wait until the India series to see if there really is any improvement against better bowlers. That will be the real test and give us a better idea of where they stand."

The 84-year-old however acknowledged that the runs would boost confidence for England's

top-order. "The top three of Zak Crawley, Ben Duckett and Ollie Pope made hundreds. Well done. It is not their fault the bowling was so poor."

"It was exactly what any batsman wants early season: easy runs. Runs breeds confidence, confidence sets you up for the summer. Form and confidence is everything. They did their job but, if we're honest, it was not a great advert for Test match cricket."

"It flattered one team and knocked seven bells out of the other one. But England's top three go into the Test series against India full of confidence. They have no excuse now."

Describing the game as a "mismatch", he added: "It was like putting a heavyweight boxer in with a flyweight. The heavyweight toyed with the flyweight before

knocking him out with one punch."

"Zimbabwe were just out of their depth. Anyone could see it. England batted first on a flat pitch and took advantage of club bowling and enjoyed easy batting practice."

England will face India in a five-Test marquee series beginning June 20 at Leeds. Their next assignment in the World Test Championship cycle will be the highprofile Ashes series in Australia, starting November 21.

"My worry for the Ashes series later this year has always been England's bowling and I saw nothing at Nottingham to change my mind."

As it was his team's third offence of the season under the IPL's Code of Conduct relating to minimum over-rate offences, Rishabh Pant was fined 30 Lakh. The remaining members of the Playing XI, including the Impact Player, were each individually fined 12 Lakh or 50 per cent of their respective match fees, whichever is lesser.

Coming to the match, with a six-run defeat against Royal Challengers Bengaluru, Lucknow's topsy-turvy IPL 2025 campaign ended on a bitter note in their home den. Churning out five victories out of their eight fixtures and then standing with a solitary win in the

last six fixtures ruled them out of the race for the playoffs.

Stand-in RCB captain Jitesh Sharma arguably played the knock of his life and lifted Royal Challengers Bengaluru to a handsome victory as they overcame Lucknow Super Giants with a six-wicket triumph in the final group stage game of the 18th season of the Indian Premier

League (IPL). Punjab stayed at the top of the standings, while RCB moved to the second spot with two more points. RCB have booked a date with Punjab Kings in Qualifier 1 on Thursday, while Gujarat Titans, who slipped to third, will face Mumbai Indians in the Eliminator on

Bengaluru pulled off the third-highest successful run chase in the tournament's history, courtesy of an unbeaten 107-run partnership between Mayank Agarwal and Jitesh Sharma. MP Khatana slams Pakistan in Paris, warns of retaliation over cross-border attacks

PARIS, May 28 (AGENCIES): BJP Rajya Sabha MP Engineer Ghulam Ali Khatana launched a fierce attack on Pakistan, accusing it of state-sponsored terrorism and defaming Islam on the global stage.

Speaking to the Indian diaspora in Paris, Khatana didn't mince words as he accused the neighbouring country of orchestrating violence across borders while portraying itself as a victim.

"We are here to tell the world—we respect our neighbour, we want their progress, but we cannot afford the killing of innocent citizens. If they send a bullet, we will fire a bomb. There is zero tolerance. Anything that happens from the side of Pakistan will be considered an act of war," Khatana declared.

Reaffirming India's robust



stance on national security, the BJP MP asserted, "If a single bullet comes from their side, we will retaliate with shells. Pakistan must understand that India is an atomic power. We will not be blackmailed."

Khatana accused Pakistan of inflicting the greatest damage

on the image of Islam, stating that its actions have globally distorted the religion's message of peace. "Pakistan has damaged Islam more than anyone else. Its true character is far from humanity. It is very important to tell the world what Pakistan is doing—this is state-sponsored

terrorism," he said. Highlighting Prime Minister Narendra Modi's diplomatic outreach, Khatana praised the initiative of sending MPs and senior officials across the world to present India's perspective on Pakistan's alleged involvement in terrorism.

"The Prime Minister has taken an excellent decision to send Indian representatives to expose Pakistan's role in promoting terror and misrepresenting Islam," he added.

Khatana also hinted at stronger measures if provocations continue from across the border. "Let's give it 15 days. After that, there will be further action. Pakistan should stop taking us lightly," he warned, signaling a potentially tougher diplomatic or military response if ceasefire violations persist.

Dimple demanded a concrete timeframe from the Home Minister for the restoration of statehood. He also called for special provisions including Free drinking water and electricity, 12 free LPG cylinders annually, Double ration distribution, Free 200 units of electricity per household, and a package for border area residents and war victims. He further pressed for the liberation and integration of PoK, Gilgit, and

Baltistan into Jammu and Kashmir.

Dimple urged Omar Abdullah and other political leaders to stand firm on demands for restoration of statehood, special status, and Article 370. "This is the time to unite and raise our voice. If the Centre does not respond, we will intensify the statehood agitation," he

warned.
Prominent local leaders including Sudeh Kumar, Mohinder Kumar, Tarsem Lal, Sgarjiet Singh, Rocky Kapoor, Shami Kumar, Happy Kumar, Narender Chowdhary, Sanjev Kumar Suny, Raju, and many others joined

Dimple in the protest.

The rally concluded with a collective appeal to the Home Minister to prioritize the concerns of the people of Jammu and Kashmir and take concrete steps to restore peace, development, and dignity to the region.
